Your reference is directed to RFx Number 3000022339 for the Invitation to Bid for the State of Louisiana – Kitchen Equipment for DOC-DWCC, which is currently scheduled to open at 10:00 AM CDT on 02/21/2024.

The following changes is are to be made to the referenced solicitation:

Questions from the Vendor and State's Responses:

Vendor Question 1: You listed item number 1 to be Hobart or equal, but only Hobart has the single point bowl installation. How important is it that the machine has single point bowl installation and that it can change speeds while running?

State's Response: *This item has been removed from the solicitation.*

Vendor Question 2: I noticed that the Mixer says, "Furnish only". Does that mean, No to Delivery, Assembly, RoD? For item number 1 you have it listed as furnish only, but items 2 and 3 are not assigned as furnish only. Are items 2 and 3 furnish only too?

State's Response: *Furnish only means provide the items and deliver to the Ship to Address; no installation or assembly is needed. All lines are furnished only.*

Vendor Question 3: They requested Qty 2 VC5ED's. Would that be two single Stacks on Legs, or one Single Stack? (A double stack on that unit would be considered part number VC55ED).

State's Response: *Two separate single stack ovens on legs.*

Vendor Question 4: On the RRE48E, yes, that is the "3/4" composite griddle plate with Stainless Cooking Surface" however, It is not available in "Extra Deep Plate". Is the Standard Depth allowable?

State's Response: *Standard depth is allowable.*
