# **20. NEW PRODUCTS**

#### 21. CONTRACT RENEWALS

# 22. CONTRACT CANCELLATION

AND ITS CORRESPONDING REGULATIONS; OR, (F) ANY LISTED REASON FOR DEBARMENT UNDER LA R.S. 39:1672.

## 23. DEFAULT OF CONTRACTOR
