- Q1) Can the University provide a list of the facilities to be assessed, as well as the following information about them?
 - Square footage
 - Year Built/Renovated
- R1) Appendix A.1 in the Compliance Plan linked in Section 1.2 of the RFP details square footage and dates built/renovated, to the extent such information is available. Additionally, the facilities to be assessed are identified in the Compliance Plan by priority in tiers 1-5. Our desire is to have tiers 1-3 assessed but 4 and 5 need not be included.
- Q2) Is Campus circulation/sidewalks to be included in the assessment?
 - If so, can the University provide:
 - Estimated number of curb ramps
 - o Estimated number of signalized intersections
 - Estimated number of linear miles of sidewalk
 - Estimated number of transit stops
- R2) Yes, campus circulation/sidewalks are to be included in the assessment.
 - The estimated number of curb ramps is 515. This includes any ramps where sidewalks intersect streets or driveways around campus.
 - The estimated number of signalized intersections is 10. All such intersections are managed by the city but are on campus or just outside the gates of campus.
 - The estimated number of linear miles of sidewalk is 50 miles, as detailed in Section 3.4.1 of the Compliance Plan.
 - The estimated number of transit stops is approximately 50, including bus stops, benches and shelters, as detailed in Section 3.5 of the Compliance Plan. Detailed stops and shelters to be included in the plan are documented in Appendix A.2 of the Compliance Plan.
- Q3) Is LSU open to receiving a proposal for that component of work alone (audit, remediation & training) or are you looking for one vendor to accomplish both physical and digital accessibility?
- R3) We are looking for one proposal to cover the entire scope of work.
