3) QUESTION: How often do vehicles rotate between the garages?

<u>ANSWER:</u> We do not alternate vehicles from garages. Westbank routes stay in the WB and Eastbank Routes stay in the Eastbank. We only rotate if needed due to rolling stock shortage due to breakdowns.

3) **QUESTION:** Is DBE certification required?

ANSWER: No.
