## Meeting Minutes

#### Items discussed:

This Pre-Bid meeting was held at the project site in Baton Rouge, Louisiana to review the bid documents, schedule, and visit the site. Items discussed were as follows:

- 01. Stephen Long introduced the project, the funding and gave a brief history of the building.
- 02. The building is currently in the process of approval to be added to the National Register of Historic Places.
- 03. Allison Keppinger gave a brief synopsis of the project's scope of work as outlined in the construction drawings.
- 04. Date of bid opening has been rescheduled for 2:00 pm Thursday, May 16<sup>th</sup>, 2024.
- **05.** All RFI's are to be submitted to the architect, Allison Keppinger, by 2:00 pm Thursday, May 2<sup>nd</sup>. Section 2.5 of the Bid Package.
- 06. Question on Tax Exemption. To be answered by Stephen Long.
  - a) Being a not-for-profit municipal government organization, the City of Baton Rouge / Parish of East Baton Rouge does not pay taxes. Contractors or vendors providing quotations should not include a sales tax *specific to their proprietary business*. However, if the Contractor has to acquire materials or equipment from another vendor that might include a sales tax, such a transaction should be factored and included in the bid price, consistent with the Bid Package p25 (GP 9 of 45) General Provisions Article 2 Instructions to Bidders:
    - 2.1.1 INTENT OF CONTRACT DOCUMENTS is to provide for construction and completion in every detail the design intent with operational systems. Any minor omissions shall not be construed as relieving the Contractor of responsibilities implied by the scope of work. All miscellaneous components, parts, anchors, accessories, or other incidental items or appurtenances required for complete assembly or installation shall be provided, whether or not specifically noted, and their cost included in the Bid. The Contractor shall furnish all labor, materials, equipment, tools, transportation and supplies required to complete the work in accordance with the plans, specifications and terms of the Contract.
- 07. Compliance with the Davis-Bacon Act is required. See page 67 of Bid Package.

- 08. Questions on Budget.
  - a) The cost estimate is \$1,000,000. The contract shall be awarded to the lowest responsible and responsive bidder, though the City/Parish reserves the right to reject bids exceeding the cost estimate.
- 09. Salvage rights of any deconstructed materials are retained by Owner, though upon review, salvage rights may be granted to Contractor. See page 87 of Bid Package section 1.04 D.
- 10. Existing window treatments at the interior to be removed, stored, and reset.
- 11. Owner to occupy portions of building during construction. Contractor to give agency 7 days notice if space needs to be vacated.
- 12. City/Parish is responsible for payment of Plan Review Fees, Permit Fees, Sewer Impact Fees, and Traffic Impact Fees.
- 13. All existing elements are to be replaced or repaired in kind. Substitutions will only be considered that either provide a higher or equal level of quality.
- 14. Question on Builder's Risk Insurance.
  - a) Section 2.21 states "Builder's Risk Insurance is not required by the City-Parish. At the time of execution of the Contract, the Contractor shall provide the Purchasing Director a surety bond on a form provided or approved by the City-Parish. The Contractor shall pay all costs, therefore. Each surety bond shall be accompanied by a power of attorney."
- 15. Mural in Main Lobby is to be removed with care, stored in secure location and reinstalled.
- 16. Alternate 2 scope of work to include upgrades to the elevator to meet Elevator Code Enforcement Upgrades from Louisiana State Legislature State Fire Marshal RS 40.

  - b) Bid's are not limited to the current elevator service provider. Current provider is Otis.
- 17. Clarification on Alternate 1 Sound Masking System control panel location in Addendum to follow.
- 18. Limestone square footage allowance to be clarified in Addendum to follow.
- 19. Parking lot in rear of building available for construction team parking and lay down space. Amount of space required to be coordinated with agency before commencement of construction.
- Potential to use on-street parking along Laurel St. and North Seventh St.
   To be coordinated after contract is rewarded.
