#### GENERAL

This specification sets forth the minimum requirements for a class 8 single unit, tandem axle truck, 52,000# gvwr with a 12 yd. dump body and hoist.

Equipment shall be new, a production model of current manufacture, and must meet all state and Federal safety and emission standards in effect at time of order.

#### **REPRESENTATIVE SPECIFICATIONS**

A Freightliner M2-106 cab and chassis and a Warren F-series dump body, with appropriate options and standard features, was used to develop these specifications and establish equivalency evaluation criteria.

Equipment of similar style, type, character, quality, features, and purpose conforming to the following detailed requirements/specifications will be considered. For evaluation purposes, bidder's proposing an exception/equivalent option/feature to those specified herein, may be required to provide manufacturer/product information (catalogue sheets, detailed specifications, pictures, etc.). This information will be evaluated against the minimum requirements of this specification. Proposed submittals that are determined not to be equivalent to the established criteria will be rejected.

#### LOUISIANA AUTHORIZED DEALER(S)

Proposed item(s) must be from a manufacturer who has at least one (1) authorized dealer <u>within the</u> <u>State of Louisiana</u> where parts and service can be obtained. Authorized dealer(s) must have properly trained technicians plus all other resources necessary to perform warranty and repair services in complete accordance with the manufacturer's requirements. A letter certifying the ability to meet this requirement, inclusive of the company name(s) and address(es) of the Louisiana authorized dealer(s), should be supplied with the bid submittal and may be required prior to award.

#### **DELIVERY & ACCEPTANCE**

Vendor shall perform a test run of each unit to verify that all features and capabilities are operating properly at time of delivery. Documentation of testing may be required prior to acceptance by the Department.

Unit(s) must be delivered completely assembled (including all components, accessories, etc.) and ready for operation without any additional preparation including, but not limited to, ensuring all fluid levels are at their full mark, fuel tank(s) is full, all necessary lubrication has been performed, etc. A Louisiana safety inspection shall be performed on each vehicle prior to delivery and a Louisiana safety inspection sticker properly affixed.



Any unit delivered under this specification is subject to rejection if there is evidence of poor workmanship, by either the vendor or the original manufacturer. Noted defects and/or nonconformance findings may be corrected by the vendor. Corrections must be completed and approved by the Equipment Engineer or his representative prior to final acceptance.

Unit(s) shall be delivered "on the ground;" DOTD will not unload nor provide any unloading equipment to the vendor/delivery driver in order to offload the unit(s).

**NOTE:** The Department will have space available for equipment to be unloaded.

**NOTE:** Invoices will not be processed for payment until the unit(s) have been inspected by the Equipment Engineer or their representative and deemed in compliance with the specifications.

#### **BID SUBMITTALS**

Any additions, deletions, or variations from the specifications should be noted in the "Bidder's Exceptions" page of this specification. Exceptions that are noted to be less than a minimum requirement will not be accepted.

Any additions, deletions or variations from the manufacturer's standard published specifications should be noted on the "Bidder's Exceptions" page of this specification. Unless otherwise noted, any items appearing in the manufacturer's standard published specifications furnished by the Bidder are assumed to be included in the Bidder's submittal.

Bidder should note on their submittal any installation(s) to the equipment that will be performed by the vendor instead of the manufacturer.

Failure to note any specification exceptions, manufacturer specification alterations, and/or vendor installations prior to award may result in rejection of the equipment at the time of delivery.

  - **1.3.4.** \*Values given here are minimums. The space between cab and dump body shall not exceed 10 inches.   - **2.2.1.3.** Tailgate: ¼" smooth steel, single panel design with perimeter bracing only; no middle bracing required



- 2.2.1. Top of bottom rail to be sloped to avoid dirt buildup
- **2.2.2.** 2" side to floor radius. Welded inserts are acceptable if they are of the same material (thickness, yield strength and chemical composition) as the floor and 100 percent (100%) continuously welded in place.
- 2.2.3. ALL welds, except crossmember to body floor, will be continuous
- **2.2.4.** Horizontal, centered, box bracing running from the front corner post of body to the rear corner post is required.
- **2.2.5.** The rear corner post to be full depth from the top of the gate to the bottom of the rear cross member, one piece fabricated to a box section of 4" X 12".
- **2.2.6.** A 10" wrap around front corner post is required.
- 2.2.7. Rear bolster shall be full width of body and have height of 9" to cover ends of longitudinals.
- **2.2.8.** There shall be twelve (12) (six (6) per side) sideboard gussets with 2" X 6" steel tubing sideboards.
- 2.2.9. 8" weld-on dump apron, ¼" plate with ¼" side wings


- 2.3. Tailgate
  - 2.3.1. 6" sloping tailgate with air operated high lift mechanism
  - 2.3.2. Air operated latches
  - 2.3.3. Tailgate to have full perimeter box bracing
  - 2.3.4. Tailgate hardware shall be mounted on top of rear corner post upper cap plate
  - 2.3.5. Upper gate hinges to be 1<sup>1</sup>/<sub>4</sub>" steel and of boomerang design
  - 2.3.6. Upper hinges shall be self-cleaning, and shall rest on top of rear post with gate in closed position
  - 2.3.7. Hinge pin and bottom gate pin to be 1¼" in diameter
  - 2.3.8. Bottom pins to be reinforced with angle inside tailgate
  - 2.3.9. Spreader chain to be %"
  - 2.3.10. Lower hardware backing plate shall be 2" and fully welded into rear corner post
  - 2.3.11. Rear cross shaft to have center support

- 2.4. Body Installation
  - **2.4.1.** A rubber or plastic (Nylon or Delrin) sill spacer shall be used between the chassis frame and body subframe. <u>WOOD SPACERS ARE NOT ALLOWED!</u>
  - **2.4.2.** Body shall be bolted to frame using brackets or fishplates, similar to below. <u>U-BOLTS ARE NOT ALLOWED!</u> **2.4.2.1.** Where possible, the upfitter should use existing holes in the chassis frame web.

2.5. Hoist

- 2.5.1. Front-mount, 3-stage telescopic, single ram, 39.2-ton capacity
- 2.5.2. NTEA Class 100 hoist
- **2.5.3.** Hoist control(s) to be mounted in cab on floor mounted enclosed pedestal, with three (3) positions for dump body section of tandem hydraulic pump, within easy reach of driver

- 2.6. Hydraulic System
  - **2.6.1.** Tandem, gear-type, hydraulic pump, 2,000 PSI rated, mounted directly to PTO
  - 2.6.2. Pump section for dump body to be rated for 29 GPM @ 1800 RPM
  - 2.6.3. Pump section for tailgate spreader to be rated for 22 GPM @ 1800 RPM
  - 2.6.4. Pump shall be air-shifted and have control valve for flow metering and easy operator access.
  - **2.6.5.** Tailgate spreader section of hydraulic pump to be equipped with dual full pressure in-cab controls (Gresen Model QDB75A07B16NA or approved equal)
  - 2.6.6. Pressure relief for both sections set at 1500 PSI
  - **2.6.7.** To include dual remote hydraulic outlets located at back end of truck frame, attached to backing plate with bulkhead fittings. The fittings are to be capped (no quick connects required). The fittings are to be installed in a protected location so that future quick connects will not extend past the pintle hitch backing plate.
  - **2.6.8.** A hydraulic reservoir of 30-gallon capacity shall be mounted to outside of truck frame, complete with a replaceable cartridge-type return line hydraulic oil filter. Return line must not have any block valves in it, and any other block valve utilized must be a full port ball valve suitable for hydraulic oil service.






#### 2.7. Trailer Hitch\*

- **2.7.1.** A 25-ton forged pintle hook mounted on ¾" (min.) steel backing plate with two (2) ¾" weld-on D-rings for safety chains. The backing plate shall be adequately gusseted and braced for the rated capacity of the pintle hook. In addition, the backside of the ¾" backing plate shall be stiffened by a ¾"x5" bar/plate welded to the backing plate, spanning the full width of the backing plate, centered with the pintle hook. See the included figure(s) below.
- **2.7.2.** Pintle hitch mounting height: 27.5" from ground to center of lunette eye
- 2.7.3. ¾" welded D-rings
- 2.7.4. Two (2) trailer electrical connection sockets: 7-pole semi & 7-pole RV style
- **2.7.5.** Gladhands and hydraulic connections recessed and/or mounted away from the pintle hitch so there is no protrusion past pintle hitch backing plate
- 2.7.6. Recessed grommet mount stop/tail/turn/reverse/clearance lights


\*The intent of this specification item and the included figure(s) is to get a single ¾" steel plate coped to fit between the truck frame rails and welded to the frame. This plate shall serve as the mount for the aforementioned pintle hook, d-rings, lights, electrical connections, hydraulic connections & gladhands.

- 2.8. Tarp System
  - **2.8.1.** Donavon "Bullet" or equal
  - 2.8.2. 12-volt, direct drive motor, torsion arm design with in-cab controls
  - 2.8.3. All wiring to be inside metal conduit
  - 2.8.4. Tarp is to be asphalt lumite material, with the edges folded and sewn, and grommets installed every 24"
  - 2.8.5. Tarp must also be resistant to punctures, abrasions and ultraviolet light

- 2.9. Additional Accessories & Features
  - 2.9.1. Two (2) sets of shovel brackets (one set on each side)
  - **2.9.2.** 3/8" thick rubber mud flaps

#### **2.10.** Electrical & Lighting

- **2.10.1.** Two (2) 6" oval grommet mount stop/turn/tail lights mounted in rear posts, with plug-in connectors **2.10.2.** Flashing light to be mounted on the dash to notify the driver that the hoist is raised and the bed is in the
  - up position



- **2.10.3.** Dump body lighting wiring shall be incorporated into one (1) harness with only two (2) leads connecting into truck chassis lighting system
- **2.10.4.** Dump body wiring shall be run inside metal conduit for protection
- **2.10.5.** Truck must be delivered with warning lights & high visibility, reflective conspicuity tape installed in accordance with these specifications and the illustrated layout below
- **2.10.6.** Warning lights shall be installed by an upfitter who is experienced in and regularly engages in the installation of automotive electronics & warning lights. Installer shall use vehicle & lighting manufacturers'

guidance along with industry best practices and techniques to ensure that lights are installed in a safe and neat manner

- **2.10.7.** All wiring and cables should be logically routed, secured, and protected with convoluted loom where possible. Rubber grommets shall be used where wires and cables penetrate any cab panels, body panels, or chassis structure. All cab and body penetrations shall be adequately sealed to prevent water from entering.
