Your reference is directed to RFx Number 3000022662 for the Invitation to Bid (ITB) for the State of Louisiana Emergency Specialty Transportation – LDH, which is currently scheduled to open at 10:00 AM CT on 05/02/2024.

The following are the Vendor's submitted questions received by the deadline date of April 18, 2024 and the State's responses:

1. **Vendor Question**: In reference to Attachment C – Scope of Work, Page 3, "Wheelchair Van should have a certified driver/EMT/EMR." Please define "certified driver".

State's Response: For this scope of work "certified driver" would be defined as a person who meets the qualifications to drive wheelchair vans as required from their medical transport company. Medical transport companies vary in types of certifications required; therefore multiple types of certifications are acceptable, however at a minimum a driver must hold at least one of the certifications.

2. **Vendor Question**: Does this require a driver to have a NEMTAC Advanced Mobility Device Securement certification (or equivalent)?

State's Response: NEMTAC Advanced Mobility Device Securement certification is an acceptable certification; however it is not the only one that is acceptable or required. A driver must hold a minimum of at least one type of medical transport certification. It could be NEMTAC, but could also be other medical transport certifications.

3. Vendor Question: Will each wheelchair van driver require an EMT/EMR certification?

State's Response: EMT/EMR certification is an acceptable certification; however it is not the only one that is acceptable. A driver must hold a minimum of at least one type of medical certification; it may be an EMT/EMR or could be others.

All else remains as on original Invitation to Bid.
