Public Content

Rationale:

On Friday, April 21, 2023, the Orleans Parish School Board submitted a fifteen (15) day advertisement for Invitation to Bidno. 24-CN-0001 for Milk, for the Child Nutrition Program for the 2023-2024 Fiscal Year. NOLA Public Schools received 1,587 downloads from the public. No addendums were issued before the bid deadline. On Friday, May 5, 2021, at 12:00 p.m. the Procurement Department received two (2) sealed bids as follows:

- 1. East Side Jersey Dairy/Prairie Farms : \$269,433.85
- 2. New Dairy OPCO. Borden: \$327,310.00

These items are to provide Milk to thirteen (12) school sites through the Orleans Parish School Board Child Nutrition Program, for the 2023-2024 school year. The menu period will be from August, 2023 through July 31, 2024. These menus are planned to comply with USDA mandatesand Dietary Guidelines. Orders will be placed on an as needed basis. Milk will be served to students at various schools where the Orleans Parish School Board Department Child Nutrition Programprovides meal service.

Since there are not currently any Disadvantaged Business Enterprise (DBE) firms that perform this service, there is no DBE participation regarding this project.
