- Method of Award: Revised to: All or None Bid shall be awarded to the lowest responsible and responsive supplier for all items. A sealed pricing model shall be used to determine the supplier quoting the lowest cost. The sealed pricing model will be made available on or after the bid due date.

#### **Price Sheet Revisions:**

- Bid pricing is hereby revised. Supplier must provide the percentage mark up on the cost that the LSP receives from Microsoft. The mark-up is limited to four decimal places. If percentage is submitted for more than four places behind the decimal, it will be rounded up or down to the nearest ten thousandth. See revised price sheets, which must be used for response.
- The awarded LSP must send a full price sheet, provided by Microsoftto the LSP, along with invoices once prepared, to the LSU A&M. These documents will be used to ensure compliance with the bid mark up percentage.

- A1) These items have been removed from the price sheet. If LSU needs these (or similar items) during the term, the price LSU will pay will be calculated by applying the mark up percentage for line item 51.
- Q2 Has Microsoft offered any special pricing amendments or any other amendments? We want to make sure our response to the attached is all encompassing and need to ensure we have the ability to price the aforementioned items.
- A2) This will be a new contract and concessions haven't been determined. LSU has revised the way we are asking for pricing, per the attached revised price sheets.
- Q3) On page #2, section 3. Method of Award, the RFP states that "all or None- Bid shall be awarded to the lowest responsible and responsive supplier for all items." Is it LSU's intention to award solely based on lowest price, or will other considerations such as value-add offerings be considered for the award?
- A3) Award will be made to the lowest responsible and responsive supplier. No other considerations such as value-add offerings will be considered.
- Q4) Under LSU's current Master Campus and School Agreement, and individual EES licensing enrollments for each of LSU's 8 institutions, are there any custom terms and conditions amendments or discount pricing amendments that are currently in place with Microsoft that will flow to the new contracted agreement term? If so, please provide copies of all custom terms and discount amendments associated with LSU's Mater Campus and School Agreement and individual EES enrollments that are in place with Microsoft.
- A4) This is currently undecided with Microsoft. LSU has revised the way we are asking for pricing, per the attached revised price sheets.
- Q5) Is LSU intending to establish new EES enrollments for each of the 8 institutions with the awarded vendor, or is it intending to extend the current EES enrollments that are in place with Microsoft?
- A5) LSU enrollments that are currently in place will remain as is.
- Q6) LSU has included part # LM7-00002 (DmstcCallingPlanEDU ShrdSvr ALNG SubsVL MVL PerUsr 120min) on their RFP, however that SKU is not currently listed on the Microsoft June 2024 EES US pricelist. Has Microsoft provided LSU with a new part number and product description to use for purposes of the RFP and the licenses to be renewed?
- A6) Part # LM7-00002 has been deleted from the price sheet. A line item for SKU LM7-00017 Teams Domestic Calling Plan Edu Sub Phone System Per User has been added to replace this deleted item.
- Q7) LSU has included part # KEX-00001 (Dyn365EMktgAdCtctT1EDU ShrdSvr ALNG SubsVL MVL Addon) on their RFP, however that SKU is not currently listed on the Microsoft June 2024 EES US pricelist. Has Microsoft provided LSU with a new part number and product description to use for purposes of the RFP and the licenses to be renewed?

- A7) These items have been removed from the price sheet. If LSU needs these (or similar items) during the term, the price LSU will pay will be calculated by applying the mark up percentage for line item 52.
- Q8) LSU has included part # KPJ-00002 (Dyn365EMktgAttachEDU ShrdSvr ALNG SubsVL MVL) on their RFP, however that SKU is not currently listed on the Microsoft June 2024 EES US pricelist. Has Microsoft provided LSU with a new part number and product description to use for purposes of the RFP and the licenses to be renewed?
- A8) These items have been removed from the price sheet. If LSU needs these (or similar items) during the term, the price LSU will pay will be calculated by applying the mark up percentage for line item 52.
- Q9) LSU has included part # AAN-20979 (Win Server Std Core Ext Security 2012 16 Core Y1 (October 2023-2024)) on their RFP, however that SKU is not currently listed on the Microsoft June 2024 EES US pricelist. Has Microsoft provided LSU with a new part number and product description to use for purposes of the RFP and the licenses to be renewed?
- A9) These items have been removed from the price sheet. If LSU needs these (or similar items) during the term, the price LSU will pay will be calculated by applying the mark up percentage for line item 52.
- Q10) We're unable to quote the exact part numbers listed on the RFQ. Would the buyer consider equivalent products under a 3-year Open Value program?
- A10) No.
- Q11) For the Azure prepay SKU, is there any way we could get a list of the resources LSU plans to use in Azure. We are having a hard time locating the SKU.
- A11) The requested Azure Prepaid Credit is to cover existing Azure resources. We want to ensure the supplier has a mechanism for additional prepaid credits purchase(s) as needed at the contracted rate if the Azure environment cost increases above the beginning of the fiscal year prepaid credits purchase.
- Q12) I've been working with my MS team on this, and they wanted to know if LSU has any amendments with pricing concessions from Microsoft.
- A12) This will be a new contract and concessions haven't been determined. LSU has revised the way we are asking for pricing, per the attached revised price sheets.
- Q13) Please confirm if the vendor is expected to submit the pricing invitation to the given bid document.
- A13) Yes, pricing must be included in bid response. See number 3 of the standard terms and conditions for additional information.
- Q14) Do we need to submit the entire document in its entirety, or are just the first page and the pricing page sufficient as the vendor response?

- A14) The first page and all pricing pages are sufficient.
- Q15) Some of the items appear to be using internal names instead of the typical Microsoft names. Are you able to provide a list of the actual Microsoft product names?
- A15) Microsoft has confirmed all product names are accurate according to their price sheets, except for PRY-00001, which has been revised to Dataverse Database Capacity AO Edu Sub and DEG-00003, which has been revised to D365 Customer Service Edu Sub Per User These have been updated on the revised price sheets.
- Q16) There are products on here that require amendments from Microsoft in order to be purchased. For example HVK-00001 CISSvrPltfrmEDU ALNG LicSAPk MVL 2017EES and HAF-00008 CoreSvrPltfrm ALNG LicSAPk MVL 2017EES. These products are typically heavily discounted. We really need to know what amendments they have or will have in place that would affect their pricing in order to be able to provide an accurate quote.
- A16) These items have been removed from the price sheet. If LSU needs these (or similar items) during the term, the price LSU will pay will be calculated by applying the mark up percentage for line item 51.
- Q17) I am also confused as to why both of these skus (HVK-00001 CISSvrPltfrmEDU ALNG LicSAPk MVL 2017EES and HAF-00008 CoreSvrPltfrm ALNG LicSAPk MVL 2017EES) are on the list and not just one or the other.
- A17) Each campus has unique licensing needs. Both LSU Alexandria and LSU Shreveport use license HAF-00008, whereas LSU A&M, LSU Ag Center, LSU Eunice, LSU HSC New Orleans, and LSU HSC Shreveport use HVK-00001.
- Q18) A lot of the part # are listed multiple times with different quantities. Do they have several different agreements and have combined everything into one quote? It's ok if they do that for the RFP process, but at some point the individual enrollments would have to be split onto separate orders.
- A18) These licenses are being bid on one ITB for the entire LSU campus system, but each campus has its own unique Microsoft Agreement number (see revised spreadsheets for each Enterprise Agreement #). In the past, it has not been an issue for the reseller who is awarded the bid to generate individual quotes to meet each campus's licensing needs. If a SKU is listed more than once on the ITB Price Sheet, then that license is needed to be offered differently (ex: Item No. 4 QLU-00002 Defender Endpoint P2 Edu Sub Per User is needed as both an Additional Product Offering and as a Faculty Offering on Line No. 5).
- Q19) Would LSU accept bids leveraging an existing cooperative agreement in lieu of the terms and conditions of the RFQ?

A19) No.

Q20) We are working on the response to the Microsoft response and was wondering if we had permission to access LSUs Microsoft licensing. This would be through Microsoft.

- A20) No, all campus licensing needs are listed in the revised spreadsheets attached.
- Q21) Are you currently in an EA?
- A21) Yes, each campus and its associated Enterprise Agreements are listed in the bid, see revised spreadsheets, with the institution in the headers of each spreadsheet.
- Q22) Are you currently purchasing through volume or open value?
- A22) Volume.
- Q23) Does LSU have SKUs that require renewal for Software Assurance?
- A23) The revised price sheets include all skus needed for software assurance renewals. No items require their own separate renewal.
- Q24) Confirm faculty count for student use benefit licensing can we request the SKU list they currently have through VLSC?
- A24) See revised spreadsheets where we have provided the current license counts faculty and student for each campus and their associated Enterprise Agreements. The SKUs provided to LSU are listed in the spreadsheets in the column "Mfr #".
- Q25) Can you confirm the Azure resources that you would like to spin up
- A25) The requested Azure Prepaid Credit is to cover existing Azure resources. We want to ensure the supplier has a mechanism for additional prepaid credits purchase(s) as needed at the contracted rate if the Azure environment cost increases above the beginning of the fiscal year prepaid credits purchase.
- Q26) For this quotation, will the University be managing the licensing or is management of the licensing required as part of the bid? If management is required, are there any specifications on how the management is to be handled? If no management is required, is this bid just for the licensing as specified for each item?
- A26) This bid is just for the licensing as specified for each item; LSU manages its own licensing.
- Q27) We're looking at submitting a proposal for the LSU Baton Rouge RFP #50001-2231, and noticed some of the part numbers may be out of date. Is LSU working on these with Microsoft and planning to release a new pricing sheet? Or is there a different course of action we should take?
- A27) Items that are not currently available from Microsoft have been removed from the bid. If LSU needs these (or similar items) during the term, the price LSU will pay will be calculated by applying the mark up percentage for line item 51 or 52.
