ADDENDUM NO. 2

PROPOSAL FOR FURNISHING A RENEWABLE CONTRACT FOR GROUNDS CARE FOR VARIOUS PROPERTY BLOCKS LOCATED ON THE CAMPUS OF THE UNIVERSITY OF LOUISIANA AT LAFAYETTE IN LAFAYETTE, LOUISIANA, AS SHOWN IN THESE SPECIFICATIONS.

The following clauses/alterations shall be made part of the original specifications as though issued at the same time and shall be incorporated integrally therewith.

Item No. 1 – Penalties for Non-Performance

The awarded contractor(s) shall provide a detailed schedule as to when services shall be provided. If services are not provided in conformity with the project bid specifications, or not performed within the requirements of the contract or contractor-provided schedule of services, the contractor agrees to pay penalties for non-performance.

For each occurrence where services were not completed per contractor-provided schedule of services (as agreed upon by the University) contractor agrees to pay the sum of \$100.00 per block, per day as awarded, until deficiencies are corrected.

In the event of an extenuating circumstance beyond the contractor's control, the contractor(s) must notify the University in writing (via email) within eight (8) hours of the scheduled service, detailing the extenuating circumstances that prevented/ is preventing them from completing their scheduled contracted duties. If no notice is given, then *penalties for non-performance* will be incurred and will accrue until all deficiencies are corrected.

Should the contractor(s) incur penalties for non-performance, the University will notify said contractor in writing (via email) and will deduct any penalty amount from contractor's monthly invoice.
