ADDENDUM NO. 3

THE PURPOSE OF THIS SOLICITATION IS TO ESTABLISH A CONTRACT TO PERFORM GROUNDS CARE FOR VARIOUS PROPERTY BLOCKS LOCATED ON THE CAMPUS OF THE UNIVERSITY OF LOUISIANA AT LAFAYETTE IN LAFAYETTE, LOUISIANA, AS SHOWN IN THESE SPECIFICATIONS.

The following clauses/alterations shall be made part of the original specifications as though issued at the same time and shall be incorporated integrally therewith.

Item No. 1 – Responses to vendor questions:

(1) On page 1 of the specifications, it states that 'Hard copies of sealed bid will no longer be accepted.' But on page 6 it states that 'Each Bidder must submit one (1) signed original bid to the Office of Purchasing' Can you please confirm that bidders are to only email the bid?	Yes, we only accept email submissions to the email provided.
(2) Can you please provide maps for the specific areas that get rye grass overseed?	Plant rye seed at the Welcome center and Quad only. Watering and fertilizing as needed at each visit. See attached map.
(3) Are the areas that receive rye grass overseed supposed to receive rye grass fertilization as well?	Plant rye seed at the Welcome center and Quad only. Watering and fertilizing as needed at each visit. See attached map.
(4) The specs state to perform weed control around shrubbery and trees, in and around the driveways, along sidewalks, signs and fences. Are contractors required to apply herbicide applications to the bed areas or just turf areas?	Herbicides should not be applied to any flower beds.
(5) On some of the provided maps, it states to fertilize shrubs. How many times should contractors fertilize the shrub areas?	No fertilization of shrubs required. Please see revised maps.
(6) Can you please confirm that this contract is strictly for mowing services only and bed areas are not included?	Bed maintenance is not included in this contract.
(7) Can you please confirm how many total herbicide applications are desired for the turf areas	Herbicide should be applied as needed.
(8) Are contractors required to fertilize the turf areas? If so, can you please specify how many fertilization applications are desired?	Please see section 8 under detailed specifications for application of fertilizer.
(9) The specs reference hand watering the rye grass areas. Do these areas have an operable irrigation system? If so, who is responsible for the operation and working order of the irrigation system?	The lawn areas in both locations do not have irrigation. Watering and fertilizing as needed at each visit.

(10) Can you please quantify the square footage for the hand watering areas?	Square footage not available at this time, see attached maps for ryegrass application.
(11) Can you please quantify how many times the contactors are required to hand water the rye grass areas?	Plant rye seed at the French House/Welcome center and Quad only. Watering and fertilizing as needed at each visit. See attached map.
(12) The specs reference hand weeding of beds but doesn't mention pruning of shrubs. Is pruning required in this bid? If so, on what frequency?	Bed and shrub maintenance will not be included in this contract.
(13) Proposal references that ULL can tell how many mowing services at the beginning of the month. If ULL reduces the frequency, does that still constitute a full service? The proposal is for a price per visit.	If the University reduces frequency at the beginning of the month, the contractor shall charge only for the number of visits in that month.
(14) In the winter months when the grass is dormant, what constitutes a full service?	Any/all of the following that apply: mowing of grass where applicable, mulching of leaves, blowing and pickup of all leaves and acorns from parking lots, sidewalks and courtyards, litter and debris pickup, as well as weed control.
(15) Are contractors required to soft edge beds even if they are not responsible for maintaining the beds in certain areas?	Yes, contractor will be responsible for soft edging of any and all beds.
(16) The specs state that the contractor shall possess a landscape license, can you please provide more information on this license specifically?	Bidders must provide contractor's license number licensed under L.A. R.S. 37:2150-2163 in one of these classifications: BUILDING CONSTRUCTION SPECIALTY: LANDSCAPING, GRADING AND
	BEAUTIFICATION 3 SPECIALTY: RECREATION & SPORTING FACILITIES & GOLF COURSES
	4 SPECIALTY: SEEDING, SODDING, LOAD & SOIL STABILIZATION, EROSION CONTROL, SHEET PILING
(17) This section also lists a horticultural license with a specialty of landscaping, grading & beautification. I believe that the landscaping, grading & beautification specialty is associated with the Louisiana contractor's license not the horticultural license. Could you please clarify?	Please see above answer #16
(18) On page 12 of 23 the specs state 'the price for grass cutting should be included in the combined monthly price. Price should reflect 0-1 visit per week not to exceed 52 weeks.' This specification states that some weeks may not get any services, can you please state a numeric value of services that bidders should price?	Contractor should 52 full service visits per block.
(19) On page 14 of 23 section 8, do you want contractors to provide a quote for the additional services? If so, can a pricing sheet be provided for these items?	No, quotes will be requested and required for payment for any additional services.
