Clarification:

1. **QUESTION**:

Why on Earth would the Parish be looking to spend Hundreds of Thousands or even More of Dollars per month to an Out of Town Third Party firm to supply more inspectors by this RFP to just sit on Stand by or Supplement Existing Staff that's not needed.

ANSWER:

This RFP is strictly for as-needed inspections and is stated as such. The contract is also intended for emergency situations, such as aftermath of a major hurricane. In those cases, the need for assistance will be assessed based on the severity of the damage. Again, the purpose is to have a back-up plan only if necessary.

2. QUESTION:

Why was SAFE Built given Advance Notice of the RFP compared to all other Bidders (Please See attached PDF Communications Dated 8-31-23 Safe Built was given in favor of all other Bidders. This seems very sketchy. In fact, it looks as though the wording from Safe built is built into the RFP. Which Creates A HUGE advantage to Safe Built and Disadvantage to any other interested Bidder. Is this legal?

ANSWER:

Safe Built was not given any advanced notice of the RFP. The attached Word document titled "SAFE BUILT Jefferson Parish, LA PSA DRAFT 08.31.23VR1" is not a Jefferson Parish contract template.

3. QUESTION:

Please define "adequate number of trained and certified personnel." Does the Parish expect a certain number of consultant resources available through the duration of the project?

ANSWER:

Number of consultant resources needed will be based on staffing shortages within the department, and/or severity of emergency situations,. In the Request for Proposals, **Part II – Scope of Work/Services, Section 2.1** a weekly average number of inspections performed by this department was provided to be used as a guide for possible maximum resources needed during non-emergencies.

Does the Parish anticipate an award day and timeframe to execute a contract? The RFP states TBD in the schedule of events. An indefinite period of time for a proposal to be valid leaves room for ambiguity for contract award. Typically, proposal validity is defined.

ANSWER:

The process for award date and contract includes an evaluation meeting to be scheduled after bid deadline, and scheduling on the Council agenda for Council approval. Although I would like to have this process move as quickly as possible, the scheduling of these two steps is dependent on committee member availability, and then agenda deadline for the next available Council Meeting.
