By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 136353 and/or Resolution No. 141125 as amended.

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.

Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

A. AWARD OF CONTRACT: JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. (For more information, please see Chapter 2, Article VII, Division 2, Sec. 2-914.1 of the Jefferson Parish Code of Ordinances.)

PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. "LSA – R.S. 38:2251-2261"

B. USE OF BRAND NAMES AND STOCK NUMBERS: Where brand names and stock numbers are specified, it is for the purpose of establishing certain minimum standards of quality. Bids may be submitted for products of equal quality, provided brand names and stock numbers are specified. Complete product data may be required prior to award.

C. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. JEFFERSON PARISH reserves the right to cancel any contract at anytime and for any reason by issuing a THIRTY (30) day written notice to the contractor.

For good cause and as consideration for executing a contract with Jefferson Parish, vendor conveys, sells, assigns and transfers to Jefferson Parish or its assigns all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of Louisiana, relating to the particular good or services purchased or acquired by Jefferson Parish.

D. PRICES: Jefferson Parish is exempt from paying sales tax under LSA-R.S. 47:301 (8)(c). All prices for purchases by Jefferson Parish of supplies and materials shall be quoted in the unit of measure specified and unless otherwise specified, shall be exclusive of state and local taxes. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

Bidders are not to exclude from participation in, deny the benefits of, or subject to discrimination under any program or activity, any person in the United States on the grounds of race, color, national origin, or sex; nor discriminate on the basis of age under the Age Discrimination Act of 1975, or with respect to an otherwise qualified handicapped individual as provided in Section 504 of the Rehabilitation Act of 1973, or on the basis of religion, except that any exemption from such prohibition against discrimination on the basis of religion as provided in the Civil Rights Act of 1964, or Title VI and VII of the Act of April 11, 1968, shall also apply. 1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.
3. Contractor must hold current applicable JEFFERSON PARISH licenses with the Department of Inspection and Code Enforcement. Contractor shall obtain any and all permits required by the JEFFERSON PARISH Department of Inspection and Code Enforcement. The contractor shall be responsible for the payment of these permits. All permits must be obtained prior to the start of the project. Contractor must also hold any and all applicable Federal and State licenses. Contractor shall be responsible for the payment of these permits and shall obtain them prior to the start of the project.

Failure to comply will cause the bid to be rejected.
5. It is the bidder's responsibility to visit the job site and evaluate the job before submitting a bid.
6. Job site must be clean and free of all litter and debris daily and upon completion of the contract. Passageways must be kept clean and free of material, equipment, and debris at all times. Flammable material must be removed from the job site daily because storage will not be permitted on the premises. Precaution must be exercised at all times to safeguard the welfare of JEFFERSON PARISH and the general public.
7. PUBLIC WORKS BIDS: All awards for public works in excess of \$5,000.00 will be reduced to a formal contract which shall be recorded at the contractor's expense with the Clerk of Court and Ex-Officio Recorder of Mortgages for the Parish of Jefferson. All awards in excess of \$25,000.00 will require both a performance and a payment bond. All purchases of applicable materials or equipment shall be made by the contractor on behalf of and as the agent of Jefferson Parish (Owner), a political subdivision of the State of Louisiana. **Background**

The Jefferson Parish Department of Floodplain Management and Hazard Mitigation has issued this bid for the purpose of obtaining responsive bids from responsible, qualified, experienced, and licensed contractors with demonstrated skills and experience to establish an as-needed contract for Post-Disaster Damage Assessments of structures throughout Jefferson Parish.

Jefferson Parish Department of Floodplain Management and Hazard Mitigation anticipates that various types of projects will be required under this contract, including windshield assessments of residential structures and substantial damage assessments/estimates of residential structures. Contractor is to provide all necessary equipment, materials, transportation, and labor for said services. Projects must be accomplished in a quality and timely manner. Therefore, it is important for Jefferson Parish to be able to procure such work from qualified contractors who have the integrity and reliability that will assure good faith performance. It is equally important for Jefferson Parish to procure such work in a manner that maximizes administrative efficiency, minimizes the time required to get the job started and completed, and maximizes economy and value.

The awarded contract will include projects primarily for the Department of Floodplain Management and Hazard Mitigation however coordination will take place with Building Permits and Code Compliance and Enforcement. The number and aggregate dollar value of total jobs to be performed under the contracts is unknown and not guaranteed. Quantities listed are Jefferson Parish's best estimate and do not obligate Jefferson Parish to order or accept more than its actual requirements during the period of this agreement as determined by actual needs and availability of appropriated funds.

**Requirements**

A valid Louisiana State Licensing Board License in Residential Construction is required at all times throughout the contract term. The Louisiana Contractor's License Number must be entered in the appropriate section of the electronic envelope.

## Scope of Work/Services

The Jefferson Parish Department of Floodplain Management and Hazard Mitigation anticipates that various types of projects will be required under this contract, including Post-Disaster Windshield Assessments according to FEMA's guidelines and Substantial Damage Assessments/Estimates according to FEMA's guidelines. Contractor will be required to use Jefferson Parish's Custom Damage Assessment Online Tool for both assessments. This tool requires a smart phone or tablet with wireless data connectivity capability and ability to take photographs. Images of the Custom Damage Assessment Online Tool with any address info redacted have been provided below for reference of the ease of use.

As-Needed Hourly Services could consist of working with the Parish Staff to create letters to property owners, assisting with preparing reports for submission to FEMA, and revisiting properties that are out of compliance with floodplain regulations. Contractor is to provide all necessary equipment, materials, transportation, and labor for said services. Projects must be accomplished in a quality and timely manner.

The cost proposal includes several line items for windshield assessments "Inside the HSDRRS" as these services can be used for a wide range of disaster events. Some disaster events will require all structures (regardless of flood zone) within the community to be assessed and others will only require a small subset of structures possibly only within the Special Flood Hazard Area (SFHA) or within a tornado path.

Large events will range from 50,000 structures to all structures which will likely be a hurricane with heavy wind or flood damage.

Medium Events will be from 1,001 to 50,000 structures and would likely be from an event that affected either the east bank or west bank of the Mississippi River.

Smaller events will be up to 1,000 homes assessed for small localized flooding or tornado damages.

All other line items in the cost proposal will be considered to be the same price regardless of the scale of the event.

### Period of Agreement

The term of any contract resulting from this solicitation shall begin upon execution, and shall continue thereafter for two years. If Jefferson Parish has not entered into a new contract for the same scope of work prior to May 1st of the year in which the contract is set to expire, then the contract shall be automatically extended until the end of the calendar year of the same year that the contract is set to expire.

### Location

Location of services to be performed shall be in unincorporated Jefferson Parish divided by inside or outside the levee system which is called the Hurricane Storm Damage Risk Reduction System (HSDRRS). All areas of the parish including southern areas of Lafitte, Barataria and Crown Point. In the event of a mutual aid agreement is put in place after a disaster other municipality may choose to use this contract for those purposes the incorporated municipalities of Kenner, Gretna, Westwego, and Harahan would follow the inside the HSDRRS rate schedule whereas the incorporated municipality of Jean Lafitte would follow the outside levee rate. Further the incorporated municipality of Grand Isle has a separate line item in the event these services are needed.

### Performance Requirements

The Parish of Jefferson will issue a written work order to contractor for each project describing the area of the parish that needs assessment and the timeframe to complete. Contractor is responsible to ensure field vehicles and personnel have identifiable logos and placards within their vehicles identifying them as a Post-Disaster Parish Contractor.

Contractor shall be ready to deploy into the field within five (5) calendar days post-disaster event and should complete windshield assessments within fourteen (14) calendar days after notice to proceed. Substantial Damage Assessments/Estimates will be assigned following the Windshield Assessments and Contractor shall be ready to deploy within five (5) calendar days of completion of Windshield Assessments.

Contractor shall provide all equipment and crews, materials, supplies necessary to perform the scope of services as defined.

Contractor must coordinate with the Department of Floodplain Management and Hazard Mitigation or assigned grant management firm to assure efficient, effective, and cost-effective project completion, and to minimize any adverse impact on assessed properties. Contractor must maintain a clear line of communication with Jefferson Parish's Department of Floodplain Management and Hazard Mitigation or assigned grant management firm for issues arising out of this contract.

Mobilization and demobilization charges are not allowed during the performance of this proposed contract.

Contractor must maintain project records of progress and provide such to the Department of Floodplain Management and Hazard Mitigation or assigned grant management firm upon request.

Contractor is required to provide the Parish with telephone and e-mail contact information for two (2) employees who will be available at all times and who have authority to authorize work. Contact information must be kept current at all times.

Contractor must maintain safe working conditions by installing, operating, maintaining vehicles in a manner that will be safe, non-hazardous, sanitary, and protective of persons and property.

### **Special Instructions**

The contractor shall maintain an adequate number of trained personnel within 24-hour drive of the metropolitan area of Jefferson Parish during Hurricane Season to perform the services of work. Contractor cannot subcontract any work without prior authorization from the department. Vendors submitting payment requests for services in connection with pre-placed emergency contracts shall provide a list of all subcontractors used in the performance of the pre-placed emergency contracts prior to payment on the contract.

Time is an essential condition of the contract. Should Contractor fail to complete damage assessments within 21 days after a notice to proceed is sent to contractor, contractor shall pay to Parish, as liquidated damages and not as a penalty, \$50.00 per job for every day in which the work has not been completed. In addition to the daily liquidated damages, all damages from this Section shall be deducted from the Contractor's invoice.

In addition, such contractor and subcontractor shall be liable to the United States (in the case of work done under contract for the District of Columbia or a territory, to such District or to such territory), for liquidated damages. Such liquidated damages shall be computed with respect to each individual laborer or mechanic, including watchmen and guards, employed in violation of the clause set forth in paragraph (b)(1) of this section, in the sum of \$29 for

“funding agreement” under 37 CFR §401.2(a), for all awarded contracts related to experimental, developmental, or research work type contracts)

(a) Definitions

(1) *Invention* means any invention or discovery which is or may be patentable or otherwise protectable under Title 35 of the United States Code, or any novel variety of plant which is or may be protected under the Plant Variety Protection Act (7 U.S.C. 2321 *et seq.*).

(2) *Subject invention* means any invention of the *contractor* conceived or first actually reduced to practice in the performance of work under this *contract*, provided that in the case of a variety of plant, the date of determination (as defined in section 41(d) of the Plant Variety Protection Act, 7 U.S.C. 2401(d)) must also occur during the period of *contract* performance.

(3) *Practical Application* means to manufacture in the case of a composition or product, to practice in the case of a process or method, or to operate in the case of a machine or system; and, in each case, under such conditions as to establish that the invention is being utilized and that its benefits are, to the extent permitted by law or government regulations, available to the public on reasonable terms.

(4) *Made* when used in relation to any invention means the conception or first actual reduction to practice of such invention.

chemical, biological or electrical characteristics of the invention. The disclosure shall also identify any publication, on sale or public use of the invention and whether a manuscript describing the invention has been submitted for publication and, if so, whether it has been accepted for publication at the time of disclosure. In addition, after disclosure to the *agency*, the *Contractor* will promptly notify the *agency* of the acceptance of any manuscript describing the invention for publication or of any on sale or public use planned by the *contractor*.

(2) The *Contractor* will elect in writing whether or not to retain title to any such invention by notifying the *Federal agency* within two years of disclosure to the *Federal agency*. However, in any case where publication, on sale or public use has initiated the one year statutory period wherein valid patent protection can still be obtained in the United States, the period for election of title may be shortened by the *agency* to a date that is no more than 60 days prior to the end of the statutory period.

extends to its domestic subsidiary and affiliates, if any, within the corporate structure of which the *contractor* is a party and includes the right to grant sublicenses of the same scope to the extent the *contractor* was legally obligated to do so at the time the *contract* was awarded. The license is transferable only with the approval of the *Federal agency* except when transferred to the successor of that party of the *contractor's* business to which the invention pertains.

(j) March-in Rights

The *contractor* agrees that with respect to any subject invention in which it has acquired title, the *Federal agency* has the right in accordance with the procedures in 37 CFR 401.6 and any supplemental regulations of the *agency* to require the *contractor*, an assignee or exclusive licensee of a subject invention to grant a nonexclusive, partially exclusive, or exclusive license in any field of use to a responsible applicant or applicants, upon terms that are reasonable under the circumstances, and if the *contractor*, assignee, or exclusive licensee refuses such a request the *Federal agency* has the right to grant such a license itself if the *Federal agency* determines that:

(1) Such action is necessary because the *contractor* or assignee has not taken, or is not expected to take within a reasonable time, effective steps to achieve practical application of the subject invention in such field of use.
