2. Questions by Vendors

a. How many new claims are received per year on average? Property damage and auto liability BI separated, if possible. Also litigated number of files vs. nonlitigated.

Property damage and auto liability BI separated, if possible. Also litigated number

of files vs. non-litigated.

b. What type of fleet-sedans, trucks, specialty vehicles? Combo?

The fleet consists of sedans, trucks, and specialty vehicles..

c. What about existing inventory-will we need to convert/take over existing claims? If yes, how many-broken down by type PD/Auto?

Yes, existing claims will need to be taken over. Currently there are approximately 53 open claims, about 4 of which are bodily injury.

d. Do historic claims from a previous vendor need to be converted to the new vendor? If yes, what is the estimated claim count to be converted? Can the previous claims be converted by API?

Yes, approximately 420 claims will need to be converted. Whether it can be done by API is unknown to the Board.

e. Start time of contract?

Start time will commence after posting of notice to proceed.

f. Requirement to be on site within 1 hour. Is that EVERY accident or certain types of accidents (injury only, non-drivable, etc.)? How many of these are estimated per year?

Yes, every incident. Approximately 70 per year.

g. What is the estimated inventory of open claims to be moved from the previous vendor to the new vendor?

Approximately 53.

h. Invoice presentation- Is it expected that all claims will be billed individually as needed or is it expected every 30 days?

One master invoice every 30 days is expected.
