Questions from the Vendor and Sheriff Office Responses:

Vendor Question 1. Page 11, Number 2 states that our responses must include a list of federally funded projects for the past 10 years. However, the scoring criteria number 3, page 16, states to list the last 5 years of federally funded projects. How many years of federally funded experience would you like to see?

Sheriff Office Response: Please provide a list of the federally funded projects in the past five (5) years.

Vendor Question 2. In the RFQ document, Page 11 notes including project examples within 10 years while Attachment B notes a 5 year limit. Which is correct?

Sheriff's Office Response: The project examples should be for the last 5 years at a minimum.

Vendor Question 3. Since there was approximately two years of interruption due to COVID, can project examples completed within the last 10 years be included?

Sheriff's Office Response: Yes. Respondents may provide project examples for up to 10 years. The purpose of the request is to determine the types and sizes of projects respondents have undertaken.

Vendor Question 4. Page 11, Item 11 of Scope of Work states "Conduct final inspection and testing". Does this refer to Final Inspection at Substantial Completion? Please clarify what testing would be associated with that under the Design team scope?

Sheriff's Office Response: Final inspection refers to the inspection of the project to confirm all punch list items identified during the Substantial Completion Inspection have been resolved and the Project Designer is confident in recommending acceptance of the project by the Lafourche Parish Sheriff's Office. Testing may be required on some of the projects when systems, such as HVAC, Target System at the Shooting Range, alarm systems, security camera systems, etc. are installed as part of a project.

Vendor Question 5. Is there an anticipated timeline for contract award?
