Section 1.0 – Site Visit:

Section 2.0 – Scope:

We extend this proposal to provide labor, materials, equipment, programming, transportation, and all other incidentals necessary to replace four (4) existing Montgomery Technology Incorporated (MTI) control systems with four (4) new (MTI) Windows 10 compatible control systems with touch screens. The work will be performed in the North Wing Pods 3A and 4C at the Jefferson Parish Correctional Center, 100 Dolhonde Street, Gretna, LA 70053.

Section 3.0 – License:


