**PURCHASE OF STATIONARY EMERGENCY STANDBY FLOOD CONTROL PUMP FOR
THE JEFFERSON PARISH DEPARTMENT OF DRAINAGE**

1. GENERAL DESCRIPTION

These specifications call for the fabrication, delivery, and acceptance of one (1) new stationary, standby, flood control, 12” diesel powered, skid mounted trash pump.

Any exception to this specification requires the vendor submit a letter attached to the documents listing in detail how it differs from the specifications. Mere attachment of brochures covering standard manufactured equipment when such differs from these specifications shall not be adequate to satisfy the letter of exceptions requirement. Such items shall include:

- A complete specification and submittal of all components and design.
- Technical data sheets conforming to the specification’s design criteria.
- Cutaway drawing showing design and dimensions conforming to specifications
- Pump curve showing flow, power, NPSHr, and efficiency
- One copy of installation and operation manuals for permanent pump systems.

Vendor must submit submittals on “equal” within three business days of request by the Drainage Department. Failure to submit will result in your bid being deemed non-responsive and will be rejected.

2. GENERAL REQUIREMENTS

The equipment shall be new current model year production. All equipment indicated as standard in the manufacturer’s published literature shall be included, whether or not it is called for in this specification. Optional equipment necessary to comply with this specification shall also be included. Include model or part numbers of the equipment that will be provided throughout this specification.

3. EQUIPMENT DESCRIPTION

Basis of Design: Global Pump model 12GSTAPICT4S1SG as manufactured by Global Pump, located in Davison, Michigan.

The pump shall have the ability to run in a completely dry condition for periods of up to 24 continuous hours at full speed.

The pump shall be an efficient, non-clog, enclosed two-vane impeller type with replaceable wear rings on both the impeller and suction cover. The separate suction cover shall be removable without disturbing the pump casing such that wear rings, impeller, and mechanical seal may be serviced with the casing mounted on the skid.

The pump shall be fitted with a fully automatic, compressor-driven venturi, air ejector priming system. The air ejector shall operate on the discharge side of the compressor, eliminating the possibility of water being drawn into the air source. The venturi will be protected from contamination by a screen in the venturi hat. A ball valve shall be provided between the venturi and the venturi hat to maintain prime after engine shutdown and to allow isolation of the priming system from the pump suction as required.

The priming system shall not use a vacuum pump or diaphragm pump, nor require the use of a foot- valve, moving parts or float gear in any part of the pump suction line. A demonstration of the pump's ability to repeatedly cycle from pump/snore/re-priming/pump shall be required.

The pump shall not require pre-filling with water to achieve prime.

CASING: The pump casing shall be cast iron and constructed so that the suction flow path is in axial alignment with the impeller eye. There shall be no turns, chambers or valves between the suction line and the impeller. The casing shall be fitted with a hand-hole cleanout fitted with a fully contoured and gasketed cast iron, hand-hole cover.

IMPELLER: The pump impeller shall be of the enclosed, two-vane, non-clog type of cast iron construction and capable of passing a 4-inch solid. The wear ring shall be an axial clearance type, made from Cast Iron, gasketed, and attached to the impeller with stainless steel cap screws.

SUCTION COVER: The pump casing shall have a separate and removable suction cover for easy access to the pump interior. The suction cover shall be cast iron.

SHAFT AND BEARINGS: The pump shaft and bearings shall be supported by a rigid cast iron bearing housing. The shaft shall be of adequate size to provide an L^3/D^4 ratio of no more than 18.3. Shaft and bearing shall be designed to withstand all imposed loads such as to provide a minimum L10 Bearing Life of 100,000 hours. Shaft shall be grade 431 stainless steel. Bearings shall be grease-lubricated anti-friction with back-to-back angular contact thrust bearings and a deep groove single-row ball radial bearing. Both bearing covers shall be protected from ingress of contaminants by lip seals.

SEALS: Seals shall be mechanical self-adjusting, non-clogging springs, with silicon carbide beveled stationary face and silicon carbide rotary face. All metal parts shall be stainless steel and elastomers shall be nitrile rubber or fluoro elastomer. The mechanical seal shall be lubricated by a glycol bath from a reservoir mounted on the pump. The reservoir shall be provided with a vented refill port and two bulls-eye sight glasses. Other than glycol level, no maintenance or adjustment shall be required between services.

The barrier fluid must be contained against the mechanical seal utilizing a secondary mechanical seal, or lip seal which has a secondary lip and a protective v-ring seal to minimize contamination. The seals ride upon a shaft sleeve that is easily replaceable during seal servicing without removing the pump shaft and is constructed of ASTM A276 Grade 431 Stainless Steel. The expected service life of the shaft sleeve exceeds that of traditional stainless steel.

The pump shall be constructed in such a way that there is an air gap between the barrier fluid seals and inboard bearing seal, which both provide an easy visual indicator of any seal leakage, and in combination with the v-ring seal protects the bearings from contamination during a catastrophic seal failure.

SUCTION AND DISCHARGE FLANGES: Shall be cast iron in accordance with ANSI (B16.1) Class 125.

PUMP O-RINGS: The casing to stuffing box cover and casing to suction cover shall be sealed by O-Rings (gaskets are not acceptable). All O-Rings shall be Nitrile rubber.

GEAR BOX: The engine shall be fitted with an SAE mount gearbox with 1.67:1 overall reduction such that pump speed is less than or equal to one half that of engine speed. The gearbox shall have same-as-engine output rotation and be sized to adequately transmit the required torque under all load conditions.

ENGINE: The engine must be a Tier 4 diesel engine with a minimum horsepower of 174 HP at 2200 RPM with a maximum torque of 750 Nm. The engine must be able to achieve the stated pump duty points below. The exhaust system shall include a muffler and silencer of suitable size and noise reduction. The engine shall meet current US EPA standards (Final Tier 4). The engine shall be capable of operating satisfactorily ultra low sulfur diesel fuel. The engine shall have a 12 or 24-volt electrical system and shall be complete with 180-amp hour rated battery and belt-driven charging system. A continuous-duty engine curve shall be supplied to the owner/engineer.

CONTROL

The electronic engine control shall display oil pressure, engine temperature, speed, battery voltage, fuel level (optional), and engine hours on a large, back-lit, graphical LCD display. The "Auto/Manual" switch shall allow simple operation and the six-button keypad shall provide control of engine starting and program settings. A dual float/transducer connector input shall be located on the bottom of the enclosure. The control shall allow engine speed and ramp times to be adjustable between maximum and minimum design operating speeds and include overspeed protection. Safety shutdown switches for low oil pressure and high-water temperature that will shut down the engine

and activate both a local alarm and a dry contact for a SCADA alarm shall be included. The foregoing details the standard control package. Many control options can be provided and these should be itemized in the bid request.

Minimum standard for design shall be equal to Controls Incorporated C4F Series (C4F-G8350-AS) with NEMA 4x polycarbonate enclosure with tinted door.

Two floats shall be provided and clearly marked, top or bottom, for easy installation into wet well. Floats shall be provided with 50-feet of cable.

The two floats shall be connected together with a single pin terminal for easy connection to control box.

MOUNTING

The pump and engine shall be mounted on a structural steel skid fitted with a minimum 260-gallon capacity fuel tank. The chassis shall be fitted with lifting bale and fork pockets.

PAINT

The pump, engine, and skid shall be shop primed and finish painted at the place of the manufacturer. Materials and thickness for priming and painting shall be in accordance with manufacturer's standards.

The complete pump assembly shall be prepared inside and outside using standards SSPC-SP10 / (Near-White Blast cleaning) and painted with a high build epoxy primer/finish, Axalta Imron polyurethane or equal, to a dry film thickness of 8.0 mils.

SPARE PARTS

In addition to the factory installed filters for the diesel drive unit, the Contractor shall provide one complete set (when applicable) of spare oil filters, fuel filters, air filters with pre-filters, vapor recovery system filters, and water filters.

In addition to the oil required to fill the engine, the contractor shall provide enough oil for one complete oil change of specified lube oil.

The vendor shall furnish a list of recommended spare parts.

Spare parts required by the owner must be itemized in the bid request.

WARRANTY

The vendor shall furnish to the owner the manufacturer’s one-year parts and labor warranty covering all parts and components and shall assign the engine and other component manufacturers’ warranties.

DELIVERY

The work under this contract shall consist of providing all pumping equipment including the pumps, drive units, and all piping, appurtenances and mechanical system as specified herein. Vendor shall notify Drainage Department two (2) weeks prior to delivery. Pumping units along with all piping, controls, flanges, and accessories are to be delivered to the Ames pump station warehouse at 5100 Rochester Drive, Marrero Louisiana. Any and all freight charges are to be included in bid price. Total delivery time starting from the date the vendor receives the purchase order shall not exceed sixty (60) calendar days.

OPERATION AND MAINTENANCE MANUAL / PUMP CURVES

All items shall be furnished at the time of pump delivery.

One (1) set of operating and maintenance manuals and start up procedures per pump unit shall be provided to the owner as a hard copy and in pdf format on a CD.

Vendor shall train and instruct owner's operator on all equipment. The vendor shall provide four (4) hours of training during the start-up tests upon delivery. Set-up for automatic operation with floats, manual operation, and all maintenance shall be the basis of training.

One (1) copy of certified pump performance curves per each unit will be furnished by manufacturer. The curve shall show the pump capacity, discharge head, speed, NPSH, and Brake horsepower requirements.

A certified continuous duty engine curve shall be supplied for each engine.

By submitting a bid, vendor agrees to comply with all provisions of Louisiana Law as well be in compliance with the Jefferson Parish Code of Ordinances, Louisiana Code of Ethics, applicable Jefferson Parish ethical standards and Jefferson Parish Resolution No. 136353 and/or Resolution No. 141125 as amended.

Jefferson Parish adheres to the Louisiana Code of Governmental Ethics, contained in Louisiana Revised Statutes Annotated, R.S. 42:1101, et seq. Vendor/Proposer by this submission, warrants that there are no "conflicts of interest" related to this procurement that would violate applicable Louisiana Law. Violation of the Louisiana Code of Governmental Ethics may result in rescission of contract, permit or licenses, and the imposition of fines and/or penalties, without contractual liability to the public in accordance with applicable law.

Unless otherwise specified, no aftermarket parts will be accepted. Unless otherwise specified, all workmanship and materials must have at least one (1) year guaranty, in writing, from the date of delivery and/or acceptance of the project. Any deviations or alterations from the specifications must be indicated and/or supporting documentation supplied with bid submission.

Bidders should submit all questions in writing via email to the Purchasing Specialist's email address as indicated above, no later than Five (5) working days prior to the bid opening. A. AWARD OF CONTRACT: JEFFERSON PARISH reserves the right to award contracts or place orders on a lump sum or individual item basis, or such combination, as shall in its judgment be in the best interest of JEFFERSON PARISH. Every contract or order shall be awarded to the LOWEST RESPONSIVE and RESPONSIBLE BIDDER, taking into consideration the CONFORMITY WITH THE SPECIFICATIONS and the DELIVERY AND/OR COMPLETION DATE. SPLIT AWARDS MADE TO SEVERAL VENDORS WILL ONLY BE GRANTED TO THOSE DEEMED RESPONSIVE AND RESPONSIBLE.

All bid prices shall remain valid for 45 days. Jefferson Parish and the lowest responsive and responsible bidder(s) by mutual written consent may mutually agree to extend the deadline for award by one (1) or more extensions of thirty (30) calendar days.

PROTESTS: Only those vendors that submit bids in response to this solicitation may protest any element of the procurement, in writing to the Director of the Purchasing Department. Written protest must be received within 48 hours of the release of the bid tabulation by the Purchasing Department. After consultation, the Parish Attorney's Office will then respond to protests in writing. PREFERENCE: Unless federal funding is directly spent by Jefferson Parish for this purchase, preference is hereby given to materials, supplies, and provisions produced, manufactured or grown in Louisiana, quality being equal to articles offered by competitors outside the state. C. CANCELLATION OF CONTRACT: JEFFERSON PARISH reserves the right to cancel all or any part if not shipped promptly. No charges will be allowed for parking or cartage unless specified in quotation. The order must not be filled at a higher price than quoted. The price quoted for work shall be stated in figures. In the event there is a difference in unit prices and totals, the unit price shall prevail.

Quantities listed are for bidding purposes only. Actual requirements may be more or less than quantities listed.

1. All bidders must attend the MANDATORY pre-bid conference and will be required to sign in and out as evidence of attendance. In accordance with LSA R.S. 38:2212(I), all prospective bidders shall be present at the beginning of the MANDATORY pre-bid conference and shall remain in attendance for the duration of the conference. Any prospective bidder who fails to attend the conference or remain for the duration shall be prohibited from submitting a bid for the project.
2. Attendance to this pre-bid conference is optional. However, failure to attend the pre-bid conference shall not relieve the bidder of responsibility for information discussed at the conference. Furthermore, failure to attend the pre-bid conference and inspection does not relieve the successful bidder from the necessity of furnishing materials or performing any work that may be required to complete the work in accordance with the specification with no additional cost to the owner.
3. Contractor must hold current applicable JEFFERSON PARISH licenses with the Department of Inspection and Code Enforcement. Contractor shall obtain any and all permits required by the JEFFERSON PARISH Department of Inspection and Code Enforcement. The contractor shall be responsible for the payment of these permits. All permits must be obtained prior to the start of the project. Contractor must also hold any and all applicable Federal and State licenses. 5. It is the bidder's responsibility to visit the job site and evaluate the job before submitting a bid.
