GENERAL

Specifications for a two-year contract for a supply of Sodium Hypochlorite (NaOCl) in small bulk deliveries, for the Jefferson Parish Department of Sewerage. The sodium hypochlorite in this specification will be used for odor control and disinfection of wastewater at the Harvey, Marrero, Bridge City, Rosethorne, Jonathan Davis, and Eastbank Wastewater Treatment Plants. The quantities listed are for bidding purposes only, and represent an approximate quantity to be purchased over the two-year period. Actual requirements may be more or less than quantities listed. Usage will be on an as needed basis.

Vendor shall not advance delivery of any material without a purchase order number from the Department of Sewerage, except in the case of an emergency declared by the director.

SPILLS

Vendor must adhere to all safety precautions in the handling of this hazardous chemical. Specifically, vendor's personnel must wear safety eye protection and chemical resistant gloves. The delivery personnel must be in complete control of this material while unloading into the tanks. In the event of a spill, the delivery personnel should determine the proper remedial actions, and proceed quickly to remediate the site properly. In the case of substantial spill, the Jefferson Parish Department of Environmental Affairs must be notified.

Contractors may not commence any work under any ensuing contract unless and until all required insurance and associated evidentiary requirements thereto have been met, along with any additional specifications contained in the **Invitation to Bid**. Except as where otherwise precluded by law, the Parish Attorney or her designee, with the concurrence of the Director of Risk Management or her designee, may agree on a case-by- case basis, to deviate from Jefferson Parish's standard insurance requirements, as provided in this Section. **Vendors requesting deviation therefrom shall submit such requests in writing, along with compelling substantiation, to the Purchasing Department prior to the bid's due date.** Any changes to the insurance requirements will be reflected in the bid specifications and addenda. Prior to contract execution and at all times thereafter during the term of such contract, contractors must provide and continuously maintain all coverages as required by the foregoing Resolutions, and the contract documents. Failure to do so shall be grounds for suspension, discontinuation or termination of the contract.

For bidding purposes, bidders must submit with bid submission a current (valid) insurance certificate evidencing the required coverages. Failure to comply will cause the bid to be rejected. The current insurance certificate will be used for proof of insurance at time of evaluation.
