Vendor's Inquiry #1:

Invitation to Bid, Item 19:

We respectfully request that this item be modified as follows: VENDOR IS RESPONSIBLE FOR INCLUDING ALL APPLICABLE TAXES IN THE BID PRICE. STATE AGENCIES ARE EXEMPT FROM ALL STATE AND LOCAL SALES AND USE TAXES. Applicable taxes would be included in any quote for non-exempt entities.

Would you accept this change?

State's Response #1:

No, any entity purchasing from this statewide contract would be tax exempt.

Vendor's Inquiry #2:

Attachment A, Item 8:

We wish to accommodate cooperative purchasing in any contract awarded from this solicitation.

Can we add taxes to any entities described in this Item 8 that are not tax exempt?

State's Response #2:

No. See response to Vendor's Inquiry #1.

Vendor's Inquiry #3:

Attachment A, Item 1, Warranty:

Our BKR 9000 radio includes a 5-year standard warranty. Our BKR5000 includes a 2-year standard warranty.

We respectfully request that this item be changed to meet our standard mobile/base station warranty which is 2 years on radios and 1 year on accessories. We have an option for entities to purchase 3 year extensions on the radio warranties. All accessories are considered consumable items, not subject to warranties greater than one year.

Would you accept this change to the requirement?

State's Response #3:

No. The three year warranty is a mandatory requirement, noted by the word "must". Please also refer to Attachment A, 12. Terms and Conditions:

"This solicitation contains all terms and conditions with respect to the commodities herein. Any vendor contracts, forms, terms, or other materials submitted with bid may cause bid to be rejected."

Vendor's Inquiry #4:

Attachment A, Item 16:

Prices shall be complete, including transportation/freight charges prepaid by bidder to destination., inside delivery, unpacking, assembly of all components and removal of all associated debris from premises. Prices should be quoted in the unit (each, box, case, hour, flat, mile, etc.) as specified in the solicitation.

Our products are delivered assembled. The struck through items are not applicable to our equipment.

Would you accept changing this requirement?

State's Response #4:

No, Please refer to Attachment A, 12. Terms and Conditions:

"This solicitation contains all terms and conditions with respect to the commodities herein. Any vendor contracts, forms, terms, or other materials submitted with bid may cause bid to be rejected." The listed language is part of our regular terms and conditions, and it is understood it may not be applicable to all products.

Vendor's Inquiry #5:

Would you allow the pricing per line item to be represented as a discount off List Price vs. a set "Bid Price"?

State's Response #5:

No. All statewide radio contracts are a set bid price. If there is a manufacturer price update during the contract period, after the first three months, the Contractor may submit the updated price list for OSP review. See Attachment A, Section 24 – Price List Changes.
