Solicitation: M7351 Single Face Display Replacement

which is scheduled to open: **September 17, 2024**

1. **Question 1:** Cabinet size 9ft-.25" H x **16ft.-.25**".

Answer 1: Yes

2. **Question 2:** Nighttime Nits. Minimum of **700** nits.

Answer 2: Yes

3. **Question 3:** ASD (engineering), is there a build-stamped drawing available for the current Daktronics unit at the ticket booth entrance into Canes River Center?

Answer 3: No ASD stamped drawings available at this time. We are still pursuing drawings from secondary sources and will make available if they are obtained. Please assume they are not available.

4. **Question 4:** The current mounting structure, which is welded /bolted to the vertical square tubing support column, is being/ planning on **being reused for the new display** unit that will be bolted and/or welded to that current structure frame. **NOTE:** This will save a lot of additional costs for the engineering and fabrication time if the current structure needs to be replaced.

Answer 4: Yes the expectation is to resuse the existing super structure for the installation of the new sign.

- 5. **Question 5:** Note:
 - A. Any additional engineering requirement by the City of Baton Rouge may be at an extra cost outside of the bid. Due to the time involved in getting new engineering and stamped drawings done at this location.,
 - B. The contractor must disassemble all digital tiles/modules, the power supply, and any communication, power lines, ribbons, and PLS inside the digital display unit and place them in customer-supply containers on site.

Answer 5:

- A. Yes noted for purposes of the bid timing if necessary engineering drawings.
- B. Yes venue will provide necessary storage containers for the disassembly.

6. **Question 6:** Is a **contractor license** specialty in signs, scoreboards, displays, or billboards (electrical or nonelectric). **As** a **minimum contractor license requirement**?

(Bass Custom Signs State of Louisiana contractor License #74809 is good until the renewal date of 9-7-26)

Answer 6: No special contractor license however I would recommend you at least have a place holder for any rewire, receptacle changouts etc. inside the sign framing as needed.

7. **Question 7:** Will the location of the power supply/line going to the current digital display be located and marked for testing of the breaker panel and current open slots in the panel? Will the service **have at least 240 vac service?**

Answer 7: Yes venue will locate the existing service. I cannot at this time guarantee the minimum voltage prior to questioning
