Materials failing to meet the specifications will be paid for according to the price adjustment schedule listed in the 2016 Louisiana Standard Specification for Roads and Bridges Book, Section 1002 or MS 158-001, revised 9/4/18 as applicable.

If material does not meet specifications at the point of delivery or pick up, the applicable pay schedule given in the specification will apply, provided the material performs satisfactorily.

If performance of the material is not satisfactory, the Department will bill the contractor for materials such as aggregate, labor, equipment and clean-up costs, or any cost necessary to correct any deficiencies detected by the Department.

GUARANTEE AND LIABILITY:

The contractor agrees to guarantee the following:

SPECIAL INSTRUCTIONS:

Please note, quantity is designated as "1" to show price per ton.

This is not an order to deliver. No specific quantities are given or guaranteed. Material will be ordered as needed. The department reserves the right to increase or decrease quantities at the same prices, terms and conditions for the life of the contract.

The successful bidder must supply at bid price quantities as ordered whether the total of such quantities are more or less than the quantities shown on the solicitation.

All Asphaltic Material shall be sampled and accepted in accordance with the standard method of sampling asphaltic materials as outlined in the Department's Sampling Manual. Low bidder(s) may be required to furnish samples for testing at no cost to the Department. BASIS OF AWARD:

The contract(s) for furnishing Liquid Asphalt herein specified for the period indicated shall be awarded separately for each location to the lowest responsive and responsible bidder(s) complying with all details of this solicitation as determined by the DOTD Procurement Director.

Bidders quoting all or none may not be considered for award.

Discounts will be accepted, but will not be considered in determining low bidder.

Vendors accepting the Cooperative Purchase Agreement understand and agree that deliveries to other State Agencies, Political Subdivisions or Quasi Agencies will be on a statewide basis.

MATERIAL AVAILABILITY:

The successful bidder(s) will be required to have on hand or immediately available an adequate supply of Liquid Asphalt in order to meet the Department's requirements, as ordered, where ordered, during the life of the contract.

PURCHASE ORDERS:

Purchase orders will be issued by the Department of Transportation and Development. Each Purchase Order will state an actual or estimated quantity that is required and all other pertinent data necessary for the contractor to make proper delivery. In no event shall material be supplied without proper authorization.

ORDERS, PENALTIES AND DEMURRAGE:

The Contractor must make deliveries against purchase orders issued by the Department, using a Certificate of Delivery for Asphaltic Materials form. Two (2) copies shall accompany all shipments and be left at point of delivery.

All orders for delivery of asphalt will be placed by the Department no later than 2:00 P.M. the day before delivery or pick up is to be made. The Contractor must either confirm the delivery will be made to the stated location at the specified time OR advise if unable to make the delivery no later than 4:00 P.M. the day the order is placed. However, the Contractor must be able to make delivery within twenty-four (24) hours of the specified delivery time unless the Department cancels the order.

In the event confirmed deliveries are not made as scheduled, the Department shall allow a two (2) hour waiting period, after which a charge of \$25.00 per each half hour delay, or fraction thereof, shall be assessed the Contractor.

In the event the contractor cannot make delivery within twenty-four (24) hours of the specified delivery time, the Department may then exercise its option to purchase the asphalt on the open market and charge the difference in the contract price and the actual cost back to the contractor. Until such assessed charges have been paid, no subsequent bid from the defaulting contractor will be considered.

Scheduled delivery time as well as in time and out time must be shown on the trucker's delivery ticket and in the event of a delay.

It shall be understood that prices bid herein shall be based on furnishing minimum truckloads. Orders for less than minimum truckloads shall be delivered in minimum tonnage equipment available to the contractor. Additional freight charges shall be invoiced separately, in the event an order is placed for delivery of less than the minimum truckload requirement.

In the event of an unloading delay caused by the carrier or contractor, free unloading time will begin when the Department begins unloading. In the event delivery is made prematurely, free unloading time will begin at the designated time set in placing at the time of order.

Should it be necessary, for any reason, to withhold unloading of asphaltic material until a sample is tested, demurrage will be to the contractor's account.

All demurrage charges shall be invoiced separately. Demurrage invoices must reference the applicable purchase order and include a copy of the trucker's delivery ticket or certificate that states the in time, out time and reason for each delay. Delivery ticket or certificate must be signed by the DOTD representative and supplied to the department with the demurrage invoice.

INVOICES:

At the time of delivery or pick-up, the contractor is to make a receipt on his own form showing complete description, the exact quantity delivered, price and extension. Such receipt must make reference to the Purchase Order Number.

Upon acceptance of the material by the Department, the contractor shall bill the Department by means of an invoice. Invoice shall make reference to the Purchase Order Number on which delivery was made.

Minimum tonnage must be billed on a separate invoice, must reference the applicable purchase order and be submitted to the Department with a copy of the delivery ticket from the carrier.

Invoice price must agree with contract price.

Invoices will be paid by the Department within the discount period or within thirty (30) calendar days from receipt of correct invoice. If contractor proposes a discount, discount period will start from receipt of correct invoice.

PAYMENTS:

In an effort to increase efficiencies and effectiveness as well as be strategic in utilizing technology and resources, DOTD strongly encourages vendor to participate in accepting Electronic Funds Transfer (EFT) payments.

EFT payments are sent from the State's bank directly to the payee's bank each weekday. The only requirement is that you have an active checking or savings account at a financial institution that can accept Automated Clearing House (ACH) credit files and remittance information electronically. CONTINUATION OF CONTRACT:

At the option of the Department of Transportation and Development and acceptance by the contractor, this contract may be extended for two (2) additional twelve (12) month periods at the same prices, terms and conditions. Contract may not exceed thirty-six (36) months.

Prior to exercising the Department's option to extend the contract, the Department will determine if an extension is in the best interest of the Department, taking into consideration current market trends, cost factors, price comparison with similar service in other states and various other factors as determined by the DOTD Procurement Director.

The continuation of this contract is contingent upon the appropriation of funds to fulfill the requirements of the contract by the legislature. If the legislature fails to appropriate sufficient monies to provide for the continuation of a contract, or if such appropriation is reduced by the veto of the Governor or by any means provided in the Appropriations Act or Title 39 of the Louisiana Revised Statutes of 1950 to prevent the total appropriation for the year from exceeding revenues for that year, or for any other lawful purpose, and the effect of such reduction is to provide insufficient monies for the continuation of the contract, the contract shall terminate on the date of the beginning of the first fiscal year for which funds are not appropriated.

TERMINATION OF CONTRACT:

The Department reserves the right to immediately terminate this contract prior to the end of the contract period for unsatisfactory performance, unsatisfactory delivery, unsatisfactory service, failure to meet specifications, misrepresentation by the contractor, fraud, collusion, conspiracy, or other unlawful means of obtaining any contract with the State, conflict of contract provisions with constitutional or statutory provisions of State or Federal Law, and/or any breach of contract. The Department reserves the right to terminate this contract prior to the end of the contract period upon giving thirty (30) days written notice to the contractor if it is considered in the best interest of the Department.

Successful contractor may request cancellation of this contract upon giving thirty (30) days written notice to the DOTD Procurement Director.

All orders delivered and in accordance with the specifications, terms, and conditions of the contract prior to the effective date of any termination shall be paid for by the Department in accordance with the terms of the contract, whereupon all obligations of both parties to the contract shall cease.
