Question 1. Do you have specs, drawings or roof reports of the roofs needing replacement? We are able to pull our own roof reports for measurements but more information is needed to complete the bid process than provided from a roof measurement report.

Answer 1. No

- Question 2. What is the existing roof? We are assuming it is R-panel secondary to the designation that it has existing skylights.
- Answer 2. You would need to do site visit to get those answers. All facilities on project are open from 7am until 3pm
- Question 3. Have y'all considered / are open to a roof coating? We offer a 20 year No Dollar Limit (NDL) warranty for all coating systems.
- Answer 3. No

- Answer 7. No specs, replace what is existing
- Question 8. Bid states to replace damaged insulation Please define damaged, is this the insulation that is ripped or does that also include water stained?
- Answer 8. Any water damaged or missing insulation
- Question 9. The building located in Pearl River part of the roof is standard seam, so what roof system is required to replace that complete roof?
- Answer 9. All will be replaced with standard seam
- Question 10. Pearl River location the insulation has appeared to be removed in the first bay on the ceiling, will that need to be installed?
- Answer 10. Yes
- Question 11. Which roof on the trace facility needs to be changed?
- Answer 11. The building marked Trace Maintenance

barn sites.


