Question:	Is a registered land surveyor required for this project?
Answer:	The Contractor is required to provide the appropriate skilled labor to perform the work of the project.
Question:	Detail says water main markers are to be used on water mains larger than 12" diameterthis job is 8" and smallerare these required?
Answer:	Water Main Markers are for water mains larger than 12-inches as noted in the detail on Sheet C-501 WATER MAIN MARKER DETAIL, and therefore not applicable on this project. Water Service Connection Markers are required and are to be paid under Bid Item 12 Waterline Pavement Markers. See Sheet G-101 Note 11 and Sheet C-501 WATER SERVICE CONNECTION DETAIL.
