ADDENDUM NO. 01

Your reference is directed to RFx Number 3000023757 for the Invitation to Bid (ITB) for the State of Louisiana – Duck Boxes - LDWF, which is currently scheduled to open at 2:00 PM CT on 10/21/24.

Questions from the Vendor and State's Responses:

Vendor Question 1. The "omit drop section below box bottom" did you mean that the back will not need to overhang the bottom of the box as to refigure the back height?

State's Response: Yes, the back will not need to overhang the bottom of the box.

Vendor Question 2. The clip corner at top is 3" but is there a specific location you want the lid of the box to be from the top edge?

State's Response: The lid mounts flush to the top of the sides and front.

Vendor Question 3. What is the total height of the back of the box?

State's Response: The total height of the back of the box is 30 inches.

Vendor Question 4. What is the height of the side of the box?

State's Response: The total height of the side of the box is 23 ¾ inches.

Vendor Question 5. What will the moisture content of the wood when referred to dried? Will it need to be KD to what percent or considered Air-dried wood to what moisture content?

State's Response: The specifications do not specify a method for drying or a % moisture content.

Vendor Question 6. What are the specs on the inside of the box (square wire vs number & depth of grooves cut specs for ducks to climb out of box)?

State's Response: *Square wire is not to be used on the inside of the box. There are not specifications for the number and depth of the grooves.*

All else remains as on original Invitation to Bid.
