Two (2) Year Contract for Landscape Maintenance Within the Right-of-way on Severn Avenue from Veterans Boulevard to W. Esplanade Avenue for the Jefferson Parish Department of Parkways.

Question & Answer:

- 1. <u>Question:</u> How many irrigation systems / controllers are covered in this contract? Answer: There are two controllers
- Question: How many irrigation zones are covered in this contract?
 <u>Answer:</u> Approximately 36 zones (15 on north controller, 21 on south controller). Irrigation includes planting bed and annual color areas only. There are no turf zones.
- Question: What are the actual site addresses of each irrigation system location?
 Answer: 3501 Severn and 3301 Severn (controller locations)
- 4. <u>Question:</u> What is the age of the irrigation system(s)? <u>Answer:</u> Approximately 2 years
- 5. <u>Question:</u> How many of the irrigation controllers are 2-wire vs. Conventional? Answer: All controllers are 2-wire systems
- 6. <u>Question:</u> What are the manufactures of the irrigation 2-Wire controllers?
 <u>Answer:</u> Rainbird
- 7. <u>Question:</u> Can we get last year's quantity of irrigation incidental items approved? (Not \$ but Qty of each)

8. <u>Question:</u> The number given for annual color is 1,380; is this the square footage of annual color area or the specific count of 6-inch annuals?

Answer: The count is the number 6" annuals required per installation

Answer: Bid as 4" as per the bid form
