## **Questions from the Vendor and State's Responses:**

**Vendor Question 1.** How many calls are received per month or per year, as well as an average call time?

**State's Response:** Per recent stats, annually we receive an average of 1500 after hours calls (Inbound and Outbound) with an average total minutes handled (Inbound and Outbound) 7512.

**Vendor Question 2.** The calls that come in, are they traumatic and/or triggering? I.e. Suicide, Rape, etc? If there are calls like that how common are they?

**State's Response:** Yes, APS receives reports involving physical and sexual abuse on a daily basis. All reports involve abuse or neglect of a vulnerable adult. Calls regarding suicidal or homicidal thoughts or actions are advised to contact 911 or call the Suicide and Crisis Lifeline at 988.

**Vendor Question 3.** Page 3 of Attachment B – Standard Operating Procedures: Line 5 & 6 How will the Answering service know whether or not the call/ message was picked up?

**State's Response:** The on-call staff member or the APS Intake Manager will contact the answering service to receive the call details.
