PART II: SCOPE OF WORK/SERVICES

2.1 Scope of Work/Services

The successful Proposer shall be responsible for providing solid waste disposal services and the specified dumpster, collection, transportation, and disposal of solid waste materials generated at each designated location. Additionally, a clean area around the dumpster(s) shall be maintained and debris created as a result of the collection activity shall be picked up and disposed of on a regularly scheduled basis.

The successful Proposer must be able to respond to irregularities in waste generation and shall respond within 24 hours to any unforeseen/special pick-ups requested by the Parish.

The barn locations are listed below:

2.2 Period of Agreement

The term of the contract will be from January 1, 2025 through December 31, 2027, with the option of two (2) additional one (1) year renewals. All prices proposed shall be firm for the initial term of the Contract. The Parish will allow one (1) escalation provision request for one (1) of the optional renewal terms. The contract shall terminate pursuant to the terms and conditions of section 5.31 herein, the terms and conditions of the contract, operation of law, as agreed between the parties, or upon satisfactory completion of all services and obligations described in the contract.

2.3 Price Schedule

All prices proposed shall be firm for the initial term of the Contract. The Parish will allow one (1) escalation provision request for either of the optional renewal terms. The escalation may not exceed the U.S. Bureau of Labor Statistics National Index for all Urban Consumers, unadjusted 12-month figure. The most recently published figure issued must be provided at the time an adjustment is requested and will be used. A request must be made in writing by the Proposer and the escalation will only be applied to services made after the request is made and the Contract is amended.
