unit only? If deficiencies/damages are found would repair be quoted separately and issued as a purchase order to maintenance contractor?

Answer 2. The cost to be provided is for the Vendor to go out to each sign once every 6 months and ensure it is in working order and provide an informational report on

each location. Regarding deficiencies or damage, the vendor should provide a quote for the repair of any deficiency or damage. STP Public Works will determine if repair work is within our budget. If we proceed with repairs a separate PO will be issued.

- Question 3. Is there a previous maintenance log available for each unit?
- Answer 3. No, a maintenance log is not available.
- Question 4. Do all signage requirements need to meet MUTCD standards?
- Answer 4. Yes, all signage requirements must meet MUTCD standards.
- Question 5. Has the parish thought of establishing pay items for the actual repairs items? Such as solar panel, battery, radar sign assembly and full assembly replacement.
