20. CONTRACT CANCELLATION:

TERMINATION FOR NONCOMPLIANCE:

LSUHSC HAS THE RIGHT TO CANCEL ANY CONTRACT, IN ACCORDANCE WITH PURCHASING RULES AND REGULATIONS, FOR CAUSE INCLUDING BUT NOT LIMITED TO THE FOLLOWING:

- (1) FAILURE TO DELIVER WITHIN THE TIME SPECIFIED IN THE CONTRACT;
- (2) FAILURE OF THE PRODUCT OR SERVICE TO MEET SPECIFICATIONS, CONFORM TO SAMPLE QUALITY OR TO BE DELIVERED IN GOOD CONDITION;
- (3) MISREPRESENTATION BY THE CONTRACTOR;
- (4) FRAUD, COLLUSION , CONSPIRACY OR OTHER UNLAWFUL MEANS OF OBTAINING ANY CONTRACT WITH THE STATE;
- (5) CONFLICT OF CONTRACT PROVISIONS WITH CONSTITUTIONAL OR STATUTORY PROVISIONS OF STATE OR FEDERAL LAW;
- (6) ANY OTHER BREACH OF CONTRACT.

TERMINATION FOR CONVENIENCE:

LSUHSC MAY, AT ANY TIME, TERMINATE THE CONTRACT FOR THEIR CONVENIENCE AND WITHOUT CAUSE. UPON RECEIPT OF WRITTEN NOTICE FROM LSUHSC OF SUCH TERMINATION FOR THEIR CONVENIENCE, THE CONTRACTOR SHALL: CEASE OPERATIONS AS DIRECTED BY LSUHSC IN THE NOTICE; TAKE ACTIONS NECESSARY, OR THAT LSUHSC MAY DIRECT, FOR THE PROTECTION AND PRESERVATION OF THE WORK; AND EXCEPT FOR WORK DIRECTED TO BE PERFORMED PRIOR TO THE EFFECTIVE DATE OF TERMINATION STATED IN THE NOTICE, TERMINATE ALL EXISTING SUBCONTRACTS AND PURCHASE ORDERS AND ENTER INTO NO FURTHER SUBCONTRACTS AND PURCHASE ORDERS. IN CASE OF SUCH TERMINATION FOR LSUHSC'S CONVENIENCE, THE CONTRACTOR SHALL BE ENTITLED TO RECEIVE PAYMENT FOR WORK EXECUTED. TERMINATION FOR NON-APPROPRIATION OF FUNDS:

THE CONTINUATION OF THIS CONTRACT IS CONTINGENT UPON THE APPROPRIATION OF FUNDS TO FULFILL THE REQUIREMENTS OF THE CONTRACT.

21. DEFAULT OF CONTRACT:

FAILURE TO DELIVER WITHIN THE TIME SPECIFIED IN THE BID WILL CONSTITUTE A DEFAULT AND MAY CAUSE CANCELLATION OF THE CONTRACT. WHERE THE UNIVERSITY HAS DETERMINED THE CONTRACTOR TO BE IN DEFAULT, THE UNIVERSITY RESERVES THE RIGHT TO PURCHASE ANY OR ALL PRODUCTS OR SERVICES COVERED BY THE CONTRACT ON THE OPEN MARKET AND TO CHARGE THE CONTRACTOR WITH COST IN EXCESS OF THE CONTRACT PRICE. 22. ORDER OF PRIORITY:

IN THE EVENT THERE IS A CONFLICT BETWEEN THE INSTRUCTIONS TO BIDDERS OR STANDARD CONDITIONS AND THE SPECIAL CONDITIONS, THE SPECIAL CONDITIONS SHALL GOVERN.

23. APPLICABLE LAW:

ALL CONTRACTS SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF LOUISIANA.

The sections below will detail the systems for HDC 130 by itself and HDC 126 and 133 as a pair since their systems are identical.

The parts list attached is not meant to be an exhaustive list of all necessary parts, but includes all major components needed to achieve the desired functionality; the integrator is responsible for providing all components for the system not specified in this document as OFE (Owner Furnished Equipment) to complete a functioning system as described in this document. The integrator is responsible for providing specifications for power, data, conduit, and floor penetration(s). The integrator is also responsible for field verification of all dimensions during the installation process. A one-line drawing of the system design must be submitted to LSUHNO for comments and revisions before installation.

This document and the Parts List associated with this project supersedes any other documents which describe general standards as dictated by LSUHNO. Any question on this or any part of the bid must be submitted as detailed in the bid documents.

All installation must be performed following the manufacturer's specifications.

HDC Auditorium (130)

Control

The entire system must be controlled with a Crestron VC-4 control system located in the LSUHNO data center; the integrator will supply the required license for the room control. The user interface with the control system will be a Crestron TS-1070 touch panel on a swivel mount. The user interface design must be coordinated with and approved by LSUHNO. The system shall take advantage of all functionality offered by the Crestron control system including but not limited to:

- Projector Power Control
- Volume Control
- Screen Control
- Source Switching
- Hide Picture on/off
- Mute mic on/off
- Mute Volume on/off
- Mediasite recorder start/stop
- The ability to send an e-mail help request to the LSUHNO Enterprise A/V Group from the touch panel

- Crestron Mobility Project must also be configured for use by LSUHNO

The majority of devices will be controlled via IP, but serial control may be required in some cases. In these cases, an interface for serial control must be provided.

The integrator will configure LSUHNO's XIO Cloud license for this room (OFE) as directed by LSUHNO.

Lectern

The lectern used for this project is OFE. The equipment housed in the lectern will include the following devices:

- 5 Crestron DM-NVX-360C Encoder/Decoder cards

The FlipTop2 will provide a power socket and two USB pass through extension cables connected to the Anker USB hub which will be connected to the lectern PC (OFE). There will also be an HDMI pass through cable for laptops (see below) and one Ethernet cable connected to the LSUHNO LAN.

Also, in the lectern will be a Furman P-8 Pro C power conditioner for the lectern equipment.

Video

All endpoints will be managed by the Crestron DM-NVX-DIR-ENT (OFE) provided by LSUHNO. The domain for the room will be configured as specified and approved by LSUHNO.

The lectern PC (OFE) will output to two of the DM-NVX-360C cards in the lectern chassis. An HDMI cable will be pulled through the FlipTop2 from the lectern top to another of the DM-NVX-360C cards for a laptop provided by a user (OFE). Two more of the NVX cards in the lectern chassis will output video via HDMI cable to the two touch monitors on the lectern top. These will display whatever signal is required, but will display the left and right hand sides of the lectern PC (OFE) at startup. One of the USB connections of two of the DM-NVX-360C cards will be used to provide USB video from the wall mounted cameras. These cameras will be mounted in the room as directed and approved by LSUHNO. The HDMI connections of the cameras will be routed via NVX to the Mediasite deck (OFE) in the rack as required (see next paragraph).

In the rack, two of the inputs of the Crestron HD-WP-4K-401-C windowing processor will be connected to two outputs from the DM-NVX-360C cards in the rack chassis. The HDMI output of the HD-WP-4K-401-C will be connected to the input of one of the DM-NVX-360C cards in the chassis to be distributed as required. The AM-3100-WF will have its output connected to another of the NVX-360C cards. The Mediasite deck (OFE) will receive the output of another of the NVX-360C cards as well as the output of the DM-NVX-D30C.

The Christie 4K13-HS projector will be mounted as directed and approved by LSUHNO. At the projector location will be a DM-NVX-D30 decoder and its HDMI output will feed the input of the projector. The projector will fill the screen top to bottom when a single source is chosen. When two sources are chosen, they will be displayed side by side using the Crestron windowing processor. When this is displayed, the projector will fill the screen side to side. This will be achieved by using presets in the projector's menu that will be recalled via programming when layouts are chosen.

The projection screen is OFE. It is 10' x 25'. On the front wall of the auditorium under the projection screen will be a 75" touch monitor which will display the left hand side of the lectern PC. The touch control will be connected via NVX USB routing to the lectern PC.

On the front face of the balcony, a Sharp 4P-B65EJ2U monitor will be mounted as a confidence monitor, fed by a Crestron DM-NVX-D30 via HDMI. It will display the output of the windowing processor to mirror what is being displayed on the projector.

Audio

All audio will be routed and managed by the Q-Sys Core 110f mounted in the rack. The analog connections for the audio processor include twelve outputs to feed the amplifiers which feed the existing JBL speakers (OFE). Program audio will be routed using AES67 audio from the Crestron NVX units in the system. This audio will be mixed with the microphone audio and output to the amplifiers. This same mix will also be routed to the Mediasite deck (OFE) via the HDMI output of the appropriate DM-NVX-360C card and to the Sennheiser MobileConnect unit (OFE) for assistive listening. A mix of the room microphones will be routed via the Core 110f to an Audinate ADP-USB-AU-2X2 to provide USB audio for Webconferencing to the lectern PC (OFE).

The lectern microphone audio will be provided by the Sennheiser gooseneck microphone connected to the Shure ANI22-XLR in the lectern. Audio for the wireless microphones will be provided from the receiver for the Sennheiser Speechline microphone receiver which will be mounted near the projection screen as directed and approved by LSUHNO.

Recording

Mounted inside of the rack will be a Mediasite RL recorder (OFE). The HDMI output of the NVX endpoint in the rack will be connected to the HDMI input of the deck (OFE) for the input into the recorder (OFE). The output of the DM-NVX-D30C card will be connected to the other HDMI input of the Mediasite recorder (OFE). Audio will be provided by the Core 110f by inserting the AES67 audio into the signal from one of the HDMI of the DM-NVX cards connected to one of the HDMI inputs of the Mediasite recorder (OFE).

Ad hoc recording control of the Mediasite deck (OFE) will be achieved through the touch panel interface using VC-4 control. Feedback from the recorder must be displayed on the touch panel indicating recorder status.

NVX Networking

The integrator will connect the NVX endpoints to a Cisco Catalyst 48 port switch (OFE) provided and configured by LSUHNO. The switch will be configured and managed by the LSUHNO Enterprise Network Group. Cabling for the DM-NVX endpoints from the network closet to this room will be provided and installed by LSUHNO.

ATTACHMENT D: AFFIRMATIVE ACTION COMPLIANCE

- (3) An analysis of upgrading, transfer and promotion for the past year to determine whether equal employment opportunity is being afforded.

ATTACHMENT E – INSURANCE REQUIREMENTS

INSURANCE REQUIREMENTS FOR SUPPLIERS

Supplier shall procure and maintain for the duration of the contract insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work hereunder by the Supplier, his agents, representatives, employees, or subsuppliers.

A. MINIMUM SCOPE OF INSURANCE

Coverage shall be at least as broad as:

1. Insurance Services Office form number GL 002 (Ed. 1/73) covering Comprehensive General Liability and Insurance Services Office form number GL 0404 covering Broad Form Comprehensive General Liability; or Insurance Services Office Commercial General Liability coverage (occurrence form CG 0001). **“Claims Made” form is unacceptable. The “occurrence form” shall not have a “sunset clause”.**
2. Insurance Services Office form number CA 0001 (Ed. 1/78) covering Automobile Liability, code 1 “any auto” and endorsement CA 0025.
3. Workers’ Compensation Insurance as required by the Labor Code of the State of Louisiana, including Employers Liability insurance.

B. MINIMUM LIMITS OF INSURANCE

Supplier shall maintain limits no less than:

1. Commercial General Liability: \$1,000,000 combined single limit per occurrence for bodily injury, personal injury and property damage (or higher limits depending on size of contract).
2. Automobile Liability: \$1,000,000 combined single limit per accident, for bodily injury and property damage.
3. Workers Compensation and Employers Liability: Worker’s Compensation limits as required by the Labor Code of the State of Louisiana and Statutory Employers Liability limits. Exception: Employers liability limit is to be \$1,000,000 when work is to be over water and involves maritime exposure.

C. DEDUCTIBLES AND SELF-INSURED RETENTIONS

Any deductibles or self-insured retention's must be declared to and approved by the University. At the option of the University, either: the insurer shall reduce or eliminate such deductibles or self-insured retention's as respects the University, its officers, officials, employees and volunteers; or the Supplier shall procure a bond guaranteeing payment of losses and related investigations, claim administration and defense expenses.

D. OTHER INSURANCE PROVISIONS

The policies are to contain, or be endorsed to contain, the following provisions:

1. General Liability and Automobile Liability Coverage

- a. The University, its officers, officials, employees, Boards and Commissions and volunteers are to be added as “additional insured” as respects liability arising out of activities performed by or on behalf of the Supplier; products and completed operations of the Supplier, premises owned, occupied, or used by the Supplier. The coverage shall contain no special limitations on the scope of protection afforded to the University, its officers, officials, employees or volunteers. It is understood that the business auto policy under “Who is an Insured” automatically provides liability coverage in favor of the University.
- b. The Supplier’s Insurance coverage shall be primary insurance as respects the University, its officers, officials, employees and volunteers. Any insurance or self-insurance maintained by the University, its officers, officials, employees or volunteers shall be excess of the Supplier’s insurance and shall not contribute with it.
- c. Any failure to comply with reporting provisions of the policy shall not affect coverage provided to the University, its officers, officials, employees, Boards and Commissions, or volunteers.
- d. The Supplier’s insurance shall apply separately to each insured against whom claim is made or suit is brought, except with respect to the limits of the insurer’s liability.

2. Worker’s Compensation and Employers Liability Coverage

The insurer shall agree to waive all rights of subrogation against the University, its officers, officials, employees and volunteers for losses arising from work performed by the Supplier for the University.

3. All Coverage's

Each insurance policy required by this clause shall be endorsed to state that coverage shall not be suspended, voided, canceled by either party, reduced in coverage or in limits except after thirty (30) days’ prior written notice by certified mail, return receipt requested, has been given to the University.

E. ACCEPTABILITY OF INSURERS

Insurance is to be placed with insurers with an A.M. Best’s rating of no less than A-:VI. This requirement will be waived for workers’ compensation coverage only for those suppliers whose workers’ compensation coverage is placed with companies who participate in the State of Louisiana Workers’ Compensation Assigned Risk Pool.

F. VERIFICATION OF COVERAGE

Supplier shall furnish the University with certificates of insurance effecting coverage required. The certificate for each insurance policy is to be signed by a person authorized by that insurer to bind coverage on its behalf. The University reserves the right to require complete, certified copies of all required insurance policies, at any time.
