This addendum is being issued to respond to questions received during the inquiry period for this RFP:

Q1 Good afternoon Paul, My name is and I'm reaching out on behalf of We came across the bid posting in the above subject line and screenshots, but had a question regarding whether this solicitation was a Small-Business Set-Aside project or not? In the "Louisiana Bid Posting" screenshot above, the solicitation showed up twice, however one time it said it was a small-business set-aside and the other did not specify. As your email was listed with the posting I figured you might be able to clarify it. Let me know when you can.

R1 The City of Baton Rouge and Parish of East Baton Rouge has established a Socially and Economically Disadvantaged Business Enterprise (SEDBE) program in accordance with Revised Statute RS 33:2233.4. It is the policy of the Parish to ensure that Eligible Business Enterprises EBE's, certified in accordance with the Parish program, have an equal opportunity to receive and participate in parish contracts.

For this project the EBR Parish Purchasing office has directed a review of the scope of work and has established a minimum EBE goal of 25% of the contract amount. All Bidders shall achieve this goal or demonstrate good faith efforts to achieve the goal.

Q2 I am reaching out to kindly request if you have information regarding the previous vendor for the airport floor care services, including their pricing details. This information would be extremely helpful as we prepare to move forward.




