This addendum is being issued to respond to written inquiries received during the inquiry period:

- Q1 We are bidding on your solicitation for Janitorial Services for East Baton Rouge Parish Library System.  
Is it mandatory that we sub-contract? We are new to Louisiana and not yet familiar with underutilized cleaning companies.
- R1 No.

- R2 No, all sizes.
- Q3 How many women-owned companies do they have working for the libraries, are libraries going in different groups like before are as a whole libraries was much more easy in groups.
- R3 Unsure of the question being asked, however, the groupings may be separated when the award is issued.
- Q4 Besides the winner of Libraries, will the Libraries are city get another vendor to help with bigger emergency projects like feces, blood, vomit, and much more.
- R4 No, the vendor chosen for the contract will handle all of those emergency calls. Blood borne pathogens and bodily fluids will be cleaned up utilizing special kits provided by the Library for those purposes.
- Q5 How many years each Vendor been in business cleaning Commercial buildings and how long.
- R5 The evaluation criteria is outlined in the RFP.
