- 3. Answer additional questions received as of 01/10/2025. See below:
 - Q. Page D1.0- Can you give further directions of what new landscaping will be required?
 - A. WHLC response: Per note on A1.0, "replacement of landscaping as needed is to be provided by the Owner." No new landscaping is to be included within this project's scope.
 - Q. Page A14.0- Is a sprinkler system required?
 - A. WHLC response: No, a sprinkler system is not required.
 - Q. Page C-2- Can we be provided a scale with dimensions for the plans and/or a new square footage PCCP?

- A. David A. Waitz Engineering response: Sheets C-1 through C-4 of the drawing set contains a bar scale of 1"=10'. The Pavement Plan, Sheet C-3, has the layout of the proposed joints and their respective dimensions. The proposed square yardage of PCCP is approximately 188.
- Q. The roof mounted relief gravity vent added in addendum 1 does not seem to have a specified size. Please advise size needed for it so that we can relay this information to the roofing subs.
- A. WHLC response: Please refer to revised sheet M1.0 issued as part of Addendum 2 for clarification on the size of the gravity vent.
- Q. Sheet A5.0 Detail 3 Wall Section calls out Insulation within CMU cavity; RE: Specs also shown on Details 1, 2, 3, 4, 5, 6, 8, 9 on Sheet A6.0 No CMU cavity insulation found in Specs. Please Advise.
- A. WHLC Response: Please refer to specification 04 20 00 Unit Masonry (sections 2.2.R and 3.3.M) for the CMU cavity insulation specifications.
- Q. Section 10 14 00 Signage section appears to be from another project. Please clarify.
- A. WHLC Response: Please refer to Addendum 1 for revised specification section 10 14 00 Signage.
- Q. Spec Section 31 13 13 Concrete Paving: Portland Cement Concrete (Class M) 901 which is a 3,000 psi mix at 28 days. Sheet C-3 of the drawings calls for 6" thick P.C.C.P. 4,000 psi at 28 days. Please advise.
- A. WHLC Response: Please proceed with providing concrete as specified on the Civil drawing sheet C-3.
- Q. Spec Section 10 11 00 Fire Protection Specialties. None shown on plans please provide quantity and location on drawings where required.
- A. WHLC Response: Please include (1) portable fire extinguisher within enclosed cabinet to be located in the field by Owner/Architect during construction.
- Q. Sheet M0.0 8 Fire Protection Notes Calls to provide an Automatix Wet Pipe Sprinkler System throughout the entire building. Please confirm that this is required.
- A. WHLC Response: No, a sprinkler system is not required. Refer to revised sheet M0.0 issued as part of Addendum 2.
