Covington

*Location 1: Highway 190 (I-12 to Collins Blvd) (HU190); Covington, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Cut the entire median and maintain plantings within the median as described below.
- Turf mowing; string trimming; edging; blowing; hand weeding; hand pruning; lawn shrub
 and tree fertilization (annually); and control (as needed); bed pre-emergent (3 times a
 year); bed post-emergent (as needed); mulching (4 times a year to maintain 3" of cover at
 all times); Hand watering (as needed to maintain health of all plant materials); debris/litter
 removal prior to each grass cutting. Any tree support must be maintained or removed
 during the maintenance contract.

*Location 2: Harrison Ave (Hwy 190-Hwy 59) (R03L034); Covington, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Cut grass on both sides from the street to the wood line, trim and cut trees and bushes away from roadway, and remove all debris. Cut clean and remove all debris from ditches. Trim tree limbs hanging over the road for trucks, buses, and Emergency Vehicles and remove debris.
- Cut grass, trim, and cut trees/ bushes in and around the retention pond between Harrison Ave and Webster and 7th St to 9th St.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting;
- Herbicide all median expansion joints the length of the project; and any tree support to be maintained or removed as needed during the maintenance contract.

*Location 3: Crestwood Blvd (R03L103); Covington, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Cut grass on both sides from street to wood line or tree line, trim bushes and hedges away from roadway, and remove debris. Cut clean and remove all debris from ditches. Cut grass in the median area trim and cut trees and pick up any debris.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project. Any tree support must be maintained or removed during the maintenance contract.

*Location 4: Penn Mill Rd/Horse Branch Rd (190-Lake Ramsey) (R03D007/R03D011); Covington, LA

Cuts: 18 cuts per year from the second week of March until the last week of November.

Description of work:

- Cut grass on both sides from street to wood line or tree line, trim bushes and hedges away from roadway and remove all debris. Cut clean and remove all debris from ditches.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project
- Any tree support to be maintained or removed as needed during the maintenance contract

*Location 5: River Rd (Hwy 437-Hwy 25) (R03H001); Covington, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Cut grass on both sides from street to wood line or tree line, trim bushes and hedges away from roadway and remove all debris. Cut clean and remove all debris from ditches.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project
- Any tree support to be maintained or removed as needed during the maintenance contract

*Location 6: Falconer Dr (R03L161); Covington, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- West side cut grass from street to wood line, trim bushes and hedges near sidewalk area.
 Clean sidewalk area for pedestrians. East side cut from street to wood line trim bushes and hedges.
- Cut and clean and remove all debris from ditches.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project.
- Any tree support to be maintained or removed as needed during the maintenance contract

*Location 7: Holiday Blvd (190-end of the road) (R03A017); Covington, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Cut grass on both sides from street to wood line or tree line, trim bushes and hedges away from roadway and remove all debris. Cut clean and remove all debris from ditches.
- Cut the entire median and maintain plantings within the median as described below.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project.
- Any tree support to be maintained or removed as needed during the maintenance contract

Location 8: River Highland Blvd (R03A044) Hwy 190 to end of road Covington, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Total Length 1465 feet on River Highland Blvd from Hwy 190 to end of Blvd. Contractor will cut from the edge of the road to the wood line on either side of the roadway and the entire median.
- Turf mowing; string trimming; edging; blowing; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project

Mandeville

*Location 9: Sharp Roundabout (R04D024); Mandeville, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

 Herbicide application as needed in planting area and all expansion joints from roadside curb to back of planting curb.

- Turf mowing; string trimming; edging; blowing; hand weeding; hand pruning; lawn shrub
 and tree fertilization (annually); ant control (as needed); bed pre-emergent (3 times a
 year); bed post-emergent (as needed); mulching (4 times a year to maintain 3" of cover at
 all times); Hand watering (as needed to maintain health of all plant materials); lawn preemergent (Twice annually); Lawn post-emergent (as needed); debris/litter removal before
 each grass cutting.
- Any tree support to be maintained or removed as needed during the maintenance contract

*Location 10: Hwy 59 & Lonesome Rd Roundabout (R04032); Mandeville, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Turf mowing; string trimming; edging; blowing; ant control (as needed; lawn pre-emergent (Twice annually); Lawn post-emergent (as needed); debris/litter removal prior to each grass cutting.
- Any tree support to be maintained or removed as needed during the maintenance contract

*Location 11: Judge Tanner Blvd (R04D179); Mandeville, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Total Length 2,490 feet on Judge Tanner Blvd from Lakeview Hospital to the roundabout. Contractor will cut 9' on either side of the roadway and the entire median.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project. Any tree support to be maintained or removed as needed during the maintenance contract

*Location 12: Holy Trinity Dr (R04D204); Mandeville, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Total Length 3,117 feet on Holy Trinity Dr from roundabout to Dove Park Rd. Contractor will cut 9' on either side of the roadway and the entire median.
- Turf mowing; string trimming; edging; blowing; tree pruning as needed; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.

- Herbicide all median expansion joints the length of the project
- Any tree support to be maintained or removed as needed during the maintenance contract

Lacombe

*Location 14: N Pontchartrain Dr (R07E053) Lacombe, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Total Length 3,600 feet on N Pontchartrain Dr starting at N. Mimosa Rd going South and stopping at Hwy 190. Cut the shoulder from the edge of the road 15 feet or to the backside of the ditch. Cut around all signs, utility poles, mailboxes, etc.
- Turf mowing; string trimming; edging; blowing; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- · Herbicide all median expansion joints the length of the project.

*Location 15: Lacombe Harbor Rd (R07H028) Lacombe, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Description of work:

- Total Length 9900 feet on Lacombe Harbor Rd starting at S Oaklawn and cut to dead end.
 Cut the shoulder from the edge of the road 15 feet or to the backside of the ditch. Cut around all signs, utility poles, mailboxes, etc.
- Turf mowing; string trimming; edging; blowing; lawn shrub and tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median expansion joints the length of the project

Slidell

Location 16: Cloverleaf @ Oak Harbor (R09J090); Slidell, LA

Cuts: 2 visits per year from the 2nd week in March until the last week of November.

Description of work:

 Remove damaged or dead palm fronds annually after the final frost of the year and remove any dead palms as needed.

*Location 17: Harbor Center Blvd. (4 areas) (R09J109); Slidell, LA

Cuts: 18 cuts per year from 2nd week in March until the last week of November.

Area and description of work:

- Lakeshore Blvd North, cut the entire median from Oak Harbor Extension to the dead end and 10' strips along both sides of the roadway. Remove damaged or dead palm fronds annually after final frost of the year and remove any dead palms as needed.
- Oak Harbor Blvd Ext., entire median and 10' strips along both sides of the road from E Howze Beach to Lakeshore Blvd N.
- E Howze Beach Rd, entire Median and 10' strips along both sides of the road from Oak Harbor Blvd Ext.
- W End Blvd, entire median and 10' strips along both sides of the roadway from Oak Harbor Blvd Extension to the entrance of gated apartment complex.
- Turf mowing; string trimming; edging; blowing; hand pruning; tree fertilization (annually); ant control (as needed); debris/litter removal prior to each grass cutting.
- Herbicide all median curb expansion joints as needed.

*Location 18: Oak Harbor Blvd Bridge(R09J090); Slidell, LA

Cuts: 18 cuts per year from the last week in March until the last week of November.

Description of work:

• Turf mowing; string trimming; herbicide around the north and south side of the tunnel from the top shoulder of the road to the bottom of hill 50' area from east and west; trim low hanging limbs in the area.
