Two (2) Year Contract to Provide Wildlife Mitigation on an as needed basis for All Jefferson Parish Departments, Agencies and Municipalities, Except Grand Isle for the Department of Recreation

Correction, Revision and Clarification:

Remove in its entirety from the bid specifications,

Section 2.0 – Scope:

We extend this bid to cover all labor, materials, equipment, and necessary essentials to mitigate wildlife for a three-year period by all departments and agencies of Jefferson Parish excluding the Town of Grand Isle, on an as-needed basis.

Replace with:

Section 2.0 – Scope:

We extend this bid to cover all labor, materials, equipment, and necessary essentials to mitigate wildlife for a two-year period by all departments and agencies of Jefferson Parish excluding the Town of Grand Isle, on an as-needed basis.

Remove in its entirety from the bid specifications,

Section 3.0 –License Requirements:

The following Louisiana State licenses shall be required for this contract
State Wildlife and Fisheries Wildlife Control Operator license
And
Louisiana State Resident Coyote Trapping Permit

Replace with:

Section 3.0 –License Requirements:

The following Louisiana State licenses shall be required for this contract

State Wildlife and Fisheries Wildlife Control Operator license

Any person or subcontractor used by the vendor for the purpose of trapping coyotes must possess a valid Louisiana State Resident Coyote Trapping Permit. Additionally, any vendor that plans to use a subcontractor that holds this Resident Coyote Trapping Permit should fully disclose the name and contact information of the subcontractor and the subcontractor would also be required to submit his own affidavits. This information will be required when the bid is submitted by the vendor.

Q1: Does the required License/Permit need to be submitted with the bid?


A1: Yes

Q2: Regarding “Line Items 0002 and 0003, are these charges able to be billed ‘per location’? or, if we are hired for 7/30 days, does that mean we would go to multiple locations at one cost?

A2: The vendor will invoice per line item per location. The monthly or weekly price will be the maximum that can be charged to that line item for working anywhere in Jefferson Parish, except Grand Isle for that time period. The vendor will submit an invoice per job.

This addendum corrects the term of the Contract to Two Years, revises the requirement for the Louisiana State Resident Coyote Trapping permit and clarifies pricing for line item 0002 and 0003.
