This will be a multi-award contract to be utilized by DOTD District 58 for the parishes and outlying parishes listed above for DOTD PICKUP. Award will not be considered for plants that are located more than 50 miles from the parishes listed above.

It will be up to the District Administrator to select the Contract with plant closest to the jobsite based upon the unit price bid and the current mileage factor. Mileage will be computed on the basis of \$0.15 per mile for the first 41 miles, then \$0.75 per mile thereafter.

Unit price bid must not exceed two digits to the right of the decimal point. Unit price submitted beyond two digits will be rounded off to the nearest second digit.

Must bid in correct unit of measure shown to be considered for award. Quote submitted in any other unit of measure may not be considered.

This is not an order to deliver. The quantity listed below is estimated usage only. No quantities are guaranteed. Material will be ordered as needed.

The department reserves the right to increase or decrease quantities at the same price, terms and conditions for the period of the contract.

The continuation of this contract is contingent upon the appropriation of funds to fulfill the requirements of the contract by the Legislature. If the Legislature fails to appropriate sufficient monies to provide for the continuation of a contract, or if such appropriation is reduced by the veto of the Governor or by any means provided in the Appropriations Act or Title 39 of the La. # 23. DEFAULT OF CONTRACTOR

FAILURE TO DELIVER WITHIN THE TIME SPECIFIED OR TO PROVIDE THE SERVICES AS SPECIFIED IN THE BID WILL CONSTITUTE A DEFAULT AND MAY CAUSE CANCELLATION OF THE CONTRACT.
