The following change is to be made to the referenced solicitation:

Replacing Attachment B – Specifications – Pages 1-5 in its entirety.

Following are the Vendors' Inquiries received by the deadline date of March 25, 2025 and the State's Responses:

Vendor's Inquiry #1: Is this a new contract or a renewal. If it is a renewal for tree services, who was the previous/current contract holder? Additionally, what is the valuation of the project?

State's Response #1: This is an Invitation to Bid (ITB) to re-establish a new contract. There was a previous contract for these services. You can submit a public records request for the previous contract details at the link below: https://www.doa.la.gov/doa/ogc/public-records-request/. The estimated valuation is \$67,302.50.

Vendor's Inquiry #2: I was reading through the bid packet for the tree services. I noticed that there may be requirements for the use of a crane, yet there is no line item in the bid packet to account for the crane. Is it possible to add a line item for crane usage in the event we are working in confined areas or storm damage trees? Or would we bill crane rental directly to the state? Crane rental is a major expense that seems to be unaccounted for in the line item description. We are looking for clarification on this matter.

State's Response #2: The specifications have been revised to remove any references to a crane. See revised Attachment B – Specifications.
