The following are the Vendor's Inquiries received by the deadline date of 04/08/2025 and the State's Responses:

Vendor's Inquiry #1: Is it the intent of the state to require an Arrow Board with power raise and lower features on both the tailgate mounted and truck mounted TMA options? Though this is common and widely available on the Trailer mounted options, the Truck Mounted and Tailgate mounted options may not allow this function due to the geometry of the folding features of these systems. The brand and Model listed for the Tailgate Mount utilizes a fixed position arrow board with vertical arms for proper operation and functionality of the system.

State's Response #1: The Equipment Specifications for lines 3.1 and 3.2 have been revised for Attachment C - DOTD EQ. Spec. 281-000B_Rev 3-5-2025 and Attachment D - DOTD EQ. Spec. 281-000D_Rev 3-5-025.
