CONTRACTOR SHALL BE RESPONSIBLE FOR THE DRAINAGE AND REFILLING OF SYSTEM. COORDINATE WITH OWNER FOR ALL SHUTDOWN AND DRAINAGE REQUIREMENTS TO ACCOMMODATE VALVE REPLACEMENT."
- 2. Reference Sheet M102, Detail 1 and 2; Add note 17 to air handling unit drain pan to read "CONTRACTOR SHALL PROVIDE NEW DRAIN PAN SIZED LARGE ENOUGH TO ACCOMMODATE EQUIPMENT AND NEW CHILLED WATER PIPING, VALVES AND CIRCUIT SETTERS. CONTRACTOR SHALL VERIFY EXACT SIZE IN FIELD."
- 3. Reference Sheet M104, Add the attached REHEAT COIL SCHEDULE See Attachment B. Test and Balance Contractor shall balance all existing reheat coils to indicated water flows. Coordinate all requirements with Controls Contractor.
