This addendum is hereby officially made a part of the referenced solicitation. The questions submitted have been answered and specifications clarified as follows.

1. Why is the bidder required to have 8 years of experience in order to be able to bid on this project? A company with 4 years of experience such as myself can have just as much experience as a company with 8. Can you please explain the reason for this requirement?

The contract is fairly complex and requires different processes and specific chemicals for different types of surfaces including those around plants and people. Different surfaces and even plant areas require specific types of cleaners as well as various levels of pressure. Because of the complexity and for safety of the property, the College must have experienced company.

2. Adding lift costs into square foot pricing is difficult and raises square foot prices greatly on buildings that may not need a lift. Can we charge for the lift as a separate charge based on market lift prices? Or based off of list receipts with an upcharge? No, pricing is to be inclusive of the labor, equipment & supplies needed to perform the job for the various height levels.

3. I see on pg.7 of the document that a contractor's license is necessary. I just want to confirm that is accurate.

Clarification: A Contractor's license is not required. The bidding company must be permitted/licensed to operate in Louisiana for the type of work listed in the bid documents. Bidder must have been in business for no less than (8) years performing commercial work of a similar size scope and must be in good standing with the Louisiana Secretary of State.

4. What is the previous contract pricing?
