The following revisions shall be incorporated in and take precedence over any conflicting part of the original contract document:

PART 1 – UNIFORM CONSTRUCTION BID FORMS:

1. For paper sealed bidders, with reference to page UCBF 1 of 4 of Part 1, Uniform Construction Bid Forms, the Bidder shall indicate the receipt of this addendum in the space provided. For online Central Bidding bidders, an acknowledgement of this addendum will be prompted by the electronic bidding program prior to formally submitting the bid. **Failure to indicate the receipt of this addendum shall be cause for the bid to be rejected.**

PART 2 – SPECIAL PROVISIONS AND CONTRACT DOCUMENTS:

1. For paper sealed bidders, with reference to page UCBF 1 of 4 of Part 1, Uniform Construction Bid Forms, the Bidder shall indicate the receipt of this addendum in the space provided. For online Central Bidding bidders, an acknowledgement of this addendum will be prompted by the electronic bidding program prior to formally submitting the bid. **Failure to indicate the receipt of this addendum shall be cause for the bid to be rejected.**

TECHNICAL SPECIFICATIONS

1. 11400 – Add the following paragraph.

2.01 – D. The following equipment is an “Approved equal” pending the product submittals meet the requirements of this Specification Section.

1. Envirodyne Systems Inc. (ESI), Model JEP-AG36

2. 11400 – Add the following paragraph.

2.12 CONTROL PANEL

- A. A control panel shall be provided for each new rotary distributor unit provided. The control panel shall include all controls required to operate as specified herein. The control panel shall operate on a power supply of 480 volts, 3-phase, 60 Hz.
- B. The control panels shall consist of a main circuit breaker, interlocked with the door, branch circuit breakers and variable frequency drive(VFD), as required. Main disconnect handle shall be lockable from the exterior of the panel. All control operations shall be accomplished by a control system with all control components mounted in one common enclosure. Control switches shall provide means to operate each distributor manually or automatically. VFD's shall be able to communicate by ethernet for future connection.
- C. The electrical control equipment shall be mounted within a NEMA-4X enclosure. The enclosure shall be equipped with a door and a 3-point latch.
- D. Control relays and equipment shall be of highest industrial quality, securely fastened to the removable back panels with screws and lock washers. Back panels shall be tapped to accept all mounting screws. Self-tapping screws shall not be used to mount any component.
- E. A 480/240-120 volt utility power and control transformer shall be provided.
- F. All operating controls and instruments shall be securely mounted on the door. All controls and instruments shall be clearly labeled to indicate function.
- G. Model selector switches shall be Hand-Off-Auto type to permit over-ride of automatic control and manual actuation or shutdown. Operation in manual mode shall bypass all safety shutdown circuits except motor overload shutdown.
- H. Run(Red) and failure(amber) indicator lamps shall be oiltight as manufactured by Allen-Bradley or equal. Lights shall be push to test type. Lamp modules shall be equipped to operate at 120 volt input. Lamps shall be easily replaceable from the control compartment door without removing lamp module from its mounted position.

- I. A six digit, nonreset elapsed time meter shall be connected to each VFD to indicate the total running time in “hours” and “tenth of hours.”
- J. Provide run and failure dry contacts for remote status.
- K. The control panel shall be equipped with a VFD as specified below. It shall be the responsibility of the control panel supplier to ensure that the control panel is designed for heat dissipation using vent’s, fans, or other means.

COMMENTS AND QUESTIONS

- 1. Will any bypass work be required?

No bypass will be required. Existing gates/valves will be used to isolate equipment.

- 2. Is there a preference or suggested work sequence?

Yes. See Special Conditions, Section 01 01 00 Summary of Work, paragraph 1.02.C.

- 3. Is the Contractor required to change the anchor bolts?

Yes, per Section 11400, paragraph 2.09.

- 4. Protective Surface Grating Depth: Specification Section 1.01.D states that the protective surface grating shall be replaced to an in-kind depth of 6” for TF#3 and TF#5, and 6.5” for TF#6, TF#7, and TF#8.

Brentwood’s polypropylene protective grating (AccuGrid) has a depth of 1¼”. Please confirm if Brentwood’s AccuGrid grating with a 1¼” depth is acceptable as a replacement.

The variance in depth is acceptable.

- 5. Protective Grating Coverage: Please confirm whether the protective grating is required to provide 100% surface coverage

Confirmed. Provide 100% surface coverage.

6. Media Layer Strength Capacity for TF#5: The scope indicates that the second from top media layer for TF#5 is to be replaced in kind.

Please confirm that the existing media layer for TF#5 has a strength capacity of 1000 psf and that this is the required minimum for the replacement material.

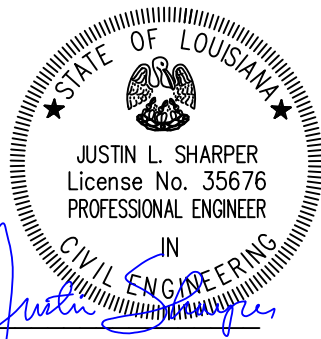
The existing media has strength capacity of 400 – 500 psf (based on available information); which is similar to what Section 06605, paragraph 2.03.B.2 refers to as “intermediate layers.”

The replacement material is required to have the minimum bearing capacity of 1000 psf as noted in Section 06605, paragraph 2.03.B.1; similar to what is referred to as “the top layer.”
