The Contractor must have a Louisiana Licenses with a classification in the following:

Contractor must have a <u>Chemical Applicator License</u> Contractor must furnish a copy of these current licenses, upon request and must maintain all licenses during the course of this contract. An employee holding the appropriate license must be on site whenever chemical services are performed. Appropriate licensing determinations are set according to Louisiana Department of Agriculture and Forestry (Phone Number 225-952-8100).

Contractors must provide NSU with a valid certificate of insurance no later than July 10 of each contract year. All insurance certificates must meet the requirements listed in Exhibit A and name Northwestern State University as the certificate holder.
