Your reference is directed to RFx Number 3000024591 for the Invitation to Bid (ITB) for the State of Louisiana – Brine Storage Tanks DOTD, which is currently scheduled to open at 10:00am CT on 05/07/25.

Questions from the Vendor and State's Responses:

Vendor Question 1. For the 4 tank sizes listed on the bid, do they have any dimensional limitations or dimensional preference (Diameter and Height) for each size listed?

State's Response: *These tanks do not need to fit within a certain area or footprint, so there are no dimensional limitations. As for dimensional preferences, we are mainly concerned with getting vertical cylinder style tanks. Our preference on height and diameter dimensions are simply that they need to be sized to allow a stable tank. These tanks will most likely be placed on a concrete slab, but a simple dirt or aggregate base is a possibility. We don't want to have to provide any other supporting structure.*

Vendor Question 2. Other than the tank manway, tank inlet fitting and tank drain fitting, are you wanting any venting, valves, or other tank fittings for optimal tank usage?

State's Response: *Venting, valves, or other tank fittings are acceptable but are not required.*

All else remains as on original Invitation to Bid.
