The following changes are issued for clarification purposes and shall be incorporated into the contract documents.

## General:

- 1. Bid has been extended until May 21, 2025. Requested for questions and substitution are extended accordingly and in alignemtn with specificaitons.
- 2. Refer to enclosed Pre-Bid Conference Meeting Report in reference to meeting held on site April 15, 2025 @ 11:00 a.m.. Report identifies items discussed and clarifications.
- It is acceptable to reflash existing equipment curbs without removing equipment, if existing curbs are in stable condition and replacement work is in compliance with manufacturers roofing warranty.
- 4. Replacement of existing canopy at loading dock is intended to reuse existing structure.

  Based upon existing documentation, this consist of structrual steel members tied back to overall building system. Original roofing at this area consisted of a copper roof system and will support new metal system design.

- 5. The intent of Demolition Keynote 7 "Existing 1 ½" x 3" copper spout to be removed and replaced with new roofing system" on Drawings Aoo3 and Aoo4, is to remove any existing exposed piping once existing foam roof is removed and seal opening. Based upon original documentation and existing conditions, it appears the exterior portion has been infilled with masonry, and the roofing side has been covered with roofing material.
- 6. Existing roofing structure is identified as sloped in original building documentation. Based upon this information, the slope varies between 1/8" per foot to 1/4" per foot.
- 7. Per Pre-bid conference, Available Funds for Construction (A.F.C.) is \$338,000.

- c. Prior Approvals / Substitutions
  - i. Fourteen working days prior to Bid Opening
  - ii. Tuesday April 8, 2025 @ 2:00 p.m.
  - iii. Time has passed. Specification allow for all State Approved roofing manufacturers, so this should not be an issue as no request have been received.
- d. Interpertations and Clarifications
  - i. Written request seven days prior to opening of bids
  - ii. April 22, 2025 @ 2:00 p.m.
- e. Addenda
  - i. Three Days prior to bid (72 hours)
  - ii. Thursday April 24, 2025 @ 2:00 p.m.
- 4. Follow State Roofing Guidelines and conferences
  - a. It is noted for all bidder to read through roofing sections if not famailar with State Roofing requirements. These are stringent and must be followed.
- 5. Coordination of schedules:
  - a. Adjacent portions of facility will remain in use.
- 6. Parking and staging to be coordinated with University during pre-construction.
- 7. Other items
  - a. A.F.C. +/- \$338,000
  - b. Base bid vs. alternate overview was provided, noting the alternate roofing scope is replacing an existing built-up roof with a spray foam covering. This is defined in documents, it is just being restating for clarification.
  - c. It was note that the processing of payments and paper work will be issued to LA Tech and then forwarded to LA State FP&C for concurance, and then issued by LA Tech University back to contractor. It was indicated the current turn around from FP&C is 10-14 days, so the processing of invoices may be extended based upon this process.
  - d. It was noted the mail system to the University creates delivery issues across all platforms. If a bidder is mailing in a bid, please be aware to send early and call purchasing to confirm receipt, as there have been isses in the past with items reaching intented locations. This applies to Fed Ex, UPS, USPS, and other delivery systems.
  - e. It was noted for all bidders to properly fill out all information required for instructions to bidders and on bid forms. If information is incorrect, bids may be rejected.

- f. Designer to provide link to additional roofing images.
- g. If anyone would like to return, please coordinate with designer and university to coordinate roof access.
- h. Meeting minutes to be issued as part of Addendum
- 8. No additional items were discussed and the group walked the site.
- 9. Meeting was adjourned.
