**State's Response:** *An extension is an acceptable option to meet the 30" Minimum specified in the specification.*

**Vendor Question 2.** *I want to verify that the 16' is a utility trailer with sides and a top rail, not an equipment/car hauler style. Also, is the landscape box to be bolted to the top rail on the front of the trailer?*

**State's Response:** *Correct, Line 2 is for a utility style trailer with sides and top rail. The storage box specified should be attached to the trailer tongue where feasible.*
