Your reference is directed to RFx Number 3000024508 for the Invitation to Bid for the State of Louisiana – Class B Uniforms – LSP/DPS, which is currently scheduled to open at 10:00 A.M. CT on May 28, 2025.

Following are the Vendor's Inquiries received by the deadline date of May 14, 2025 and the State's Responses:

Vendor's Inquiry #1: The majority of State agencies across the country have been mandating a move away from uniforms that contain PFAS chemicals. The DWR coating that is specified on the garments in this contract may contain PFAS chemicals. Has the State given any consideration to this? Some other contracts we've seen have required third party testing reports to prove that the garments do not contain any PFAS chemicals.

State's Response #1: As of January 1, 2025, Blauer products are expected to be free of PFAS and PFOA. While efforts are underway to eliminate the use of these substances, no testing is currently being conducted at this time. However, this does not rule out the possibility of testing or requiring testing in the future.

All else remains as on original bid.
