State's Response: *We will not have any solvents in the oven. We will be conditioning specimens for the AASHTO T-380 test. The oven will be used to maintain concrete specimens submerged in sodium hydroxide solution at 140 degrees Fahrenheit. These specimens will be placed in food-grade rubbermaid containers which will be set on the oven racks.*
