# ORDERS, PENALTIES AND DEMURRAGE:

The District will confirm the delivery no later than 2:00 P.M. the day before delivery or pick up is to be made. The Contractor must either confirm the delivery will be made to the stated location at the specified time OR advise if unable to make the delivery no later than 4:00 P.M. the day the order is placed. However, the Contractor must be able to make delivery within twenty-four (24) hours of the specified delivery time unless the District cancels the order.

In the event confirmed deliveries are not made as scheduled, the Department shall allow a two (2) hour waiting period, after which a charge of \$25.00 per each half hour delay, or fraction thereof, shall be assessed the Contractor.

Scheduled delivery time as well as in time and out time must be shown on the trucker's delivery ticket and in the event of a delay.

In the event of an unloading delay caused by the carrier or contractor, free unloading time will begin when the Department begins unloading. In the event delivery is made prematurely, free unloading time will begin at the designated time set in placing at the time of order.

Should it be necessary, for any reason, to withhold unloading of asphaltic material until a sample is tested, demurrage will be paid to the contractor.

All demurrage charges shall be invoiced separately. Demurrage invoices must reference the applicable purchase order and include a copy of the trucker's delivery ticket or certificate that states the in time, out time and reason for each delay. Delivery ticket or certificate must be signed by the DOTD representative and supplied to the department with the demurrage invoice.
