Scope:

The University specifically desires the photographer take these pictures as the individual student is shaking the hand of the University President on stage. **Photographer will not appear on the stage.**

Term of Contract: This initial contract will begin on July 1, 2025, and end on June 30, 2026. At the option of Northwestern State University and the acceptance by the Contractor, this contract may be extended for two (2) additional twelve (12) month periods at the same terms, prices, and conditions. Contract not to exceed thirty-six (36) months.

Graduation Dates for the 2025-2026 Fiscal Year are:

Fall, 2025 -	December 17-18, 2025
Spring, 2026 -	May 13-14, 2026

The University specifically desires the photographer take these pictures as the individual student is leaving the stage or shaking the hand of the University President. Photographer will not appear on the stage.

1. Photographic services provided at no cost to NSU and requiring no NSU manpower during the ceremony.
2. Photographers are to be as unobtrusive as possible causing no delay in the Commencement Ceremony.
3. Students are to be provided online or mailed proofs free of charge, without any purchase obligation.
4. Photographs to be of the finest quality color.
5. Charges are not to be made to the students unless prints are ordered.
6. All monetary transactions will be between the student and the Contractor.
