### QUESTIONS & ANSWERS

**Question #1: Is this job a Davis Bacon Act job?**

**Answer: This is not a Davis Bacon Act job.**

**Question #2: What is the estimated construction budget?**

**Answer: The estimated construction budget is \$ 0 – \$250,000.00.**

**Question #3: Can I get a copy of the plan holder's list?**

**Answer: The department stated there is no plan holder's list for this bid.**

**Question #4: Do you have Union Requirements?**

**Answer: The department stated there are no Union requirements with this bid.**

**Question #5: The bid docs for this project do not give any indication as to where the structures will be located. We need a general location, so we determine whether the concrete can be poured directly out of the truck, or if we have to bring in a pump or transporter for the pour. If someone could just draw some circles on a google earth map, that would be of great assistance?**

**Answer: The requesting department recommends scheduling a site visit. Please refer to the specifications, page labeled SP – Page 1 of 11, for instructions on how to arrange a site visit.**

**Question #6: Please note whether the shelters are "Line Item #1" or "Line Item #2" when preparing the drawing/sketch?**
