Annual contract for the Rental, Installation and Maintenance of New Ice Machines and Bins at various locations throughout LADOTD District 62 including Headquarters in Hammond, LA, Maintenance Units & PE Offices as listed below for a period of twelve (12) months beginning July 1, 2025.

At the option of the Department of Transportation and Development and acceptance by the contractor, this contract may be extended for two (2) additional twelve (12) month periods at the same terms, prices and conditions. Contract may not exceed thirty-six (36) months.

Prior to exercising the Department's option to extend contract, the Department will determine if an extension is in the best interest of the Department, taking into consideration current market trends, cost factors, price comparison with similar service in other States and various other factors as determined by the DOTD Procurement Director.

The continuation of this contract is contingent upon the appropriation of funds to fulfill the requirements of the contract by the legislature. If the legislature fails to appropriate sufficient monies to provide for the continuation of a contract, or if such appropriation is reduced by the veto of the Governor or by any means provided in the Appropriations Act or Title 39 of the Louisiana Revised Statutes of 1950 to prevent the total appropriation of the year from exceeding revenues for that year, or for any other lawful purpose, and the effect of such reduction is to provide insufficient monies for the continuation of the contract, the contract shall terminate on the date of the beginning of the first fiscal year for which funds are not appropriated.

The Department of Transportation and Development reserves the right to cancel this contract with thirty (30) days written notice.

The service location(s) listed are estimated to be the amount needed; however, the Department reserves the right to increase or decrease the locations on an as needed basis. If the Department enacts their right to add or remove locations, the Contractor shall provide a revised quote, as applicable, to reflect the new service location(s). Revised quote shall be under the same terms and conditions of the original contract award. Necessary changes will be administered via contract amendment.

#### SPECIAL INSTRUCTIONS:

Must bid in correct unit of measure shown to be considered for award. Quote submitted in any other unit of measure will not be considered.

Unit price must not exceed two digits to the right of the decimal point. Unit price submitted beyond two digits will be rounded off to the nearest second digit.

#### 20. NEW PRODUCTS

#### 21. CONTRACT RENEWALS

#### 22. CONTRACT CANCELLATION

AND ITS CORRESPONDING REGULATIONS; OR, (F) ANY LISTED REASON FOR DEBARMENT UNDER LA R.S. 39:1672.

### **23. DEFAULT OF CONTRACTOR**
